# WILDFIRE DANGER LEVEL DECREASES IN SOUTH CENTRAL OREGON

Lakeview – Effective at 1 a.m. on Tuesday, Sept. 23, the Industrial Fire Precaution Level (IFPL) will drop to an IFPL II on lands administered by the Lakeview District Bureau of Land Management (BLM) and the Bly, Lakeview, Paisley and Silver Lake Ranger Districts on the Fremont-Winema National Forests. The Chemult, Chiloguin and Klamath Ranger Districts remain at IFPL II.

The only Lakeview District BLM-managed lands not covered by this order are those within the Klamath Falls Resource Area that are west of the Langell Valley. This area is under the fire protection of the Oregon Department of Forestry (ODF). Under IFPL II, the following fire precautionary requirements are placed on power saw and welding operations:

- Power saws and welding equipment may not be operated between the hours of 1 p.m. and 8 p.m.
- All power saw exhaust systems must be in good repair and include a screen-type spark arrester of 0.023 inches or less.
- All power saw operators must be in possession of the following equipment:
  - A long-handled, round point shovel with a blade not less than eight inches wide: and
  - A pressurized chemical fire extinguisher of not less than eight ounces capacity by weight.

- Before refueling a power saw, the refueling spot must be clear of all flammable material, including vegetation. The chainsaw must be restarted only after the operator has moved away from the refueling area.
- All power saw operators must stay in the cutting area for one hour after the chainsaw is shut off to watch for fire starts.

Personal and commercial woodcutters are reminded of their responsibility to stay informed of current IFPLs and all restrictions that apply to activities conducted on public lands. Failure to comply with fire precautionary requirements may result in the issuance of a Violation Notice.
