### Enterprise Architecture (EA) Assessment Framework V2.1 Released

In December 2006, the newest version of the Enterprise Architecture Assessment Framework (EAAF) – Version 2.1 – was released in final to agencies. This version was released for agency review in August 2006. EAAF v2.1 is the basis of the annual EA assessment and reflects new initiatives and guidance developed within the Federal Enterprise Architecture community. Consistent with the organization of the prior version of the framework, EAAF v2.1 is organized into three (3) capability areas: Completion, Use and Results. The number of criteria has been reduced from 17 to 13, with an increased emphasis on the completion of mission-focused segment architecture, integration of Federal Transition Framework (FTF) cross-agency initiatives, and measurement of results (e.g. cost savings, cost avoidance).

## FEA Practice Guidance Supports Value to the Mission

In December 2006, the Office of Management and Budget (OMB), in cooperation with the CIO Council Architecture and Infrastructure Committee (AIC), released guidance describing important concepts architects can use with business owners to deliver value to their agency's mission. The two primary concepts described in the guidance are: segment architecture and EA transition strategy. **Segment architecture** provides a detailed results-oriented architecture for a portion or segment of the enterprise. The **EA transition strategy** describes the plan for an agency or segment to achieve its target architecture. #### Federal Transition Framework (FTF) Version 1.0 Available

In December 2006, Version 1.0 of the FTF Catalog was released containing a total of 18 Cross-Agency initiatives. The FTF is a catalog of architectural information and implementation guidance for cross-agency initiatives using a simple, familiar structure aligned with the Federal Enterprise Architecture (FEA) Reference Models. The FTF allows agencies to:

- Receive consistent, complete and detailed information about cross-agency initiatives more quickly to inform their enterprise architecture, capital planning and implementation activities;
- Use information describing cross-agency initiatives to make better informed decisions about their IT investments; and
- Improve the effectiveness and efficiency of IT investments to realize service improvements and cost savings.

#### Federal Government IPv6 Standards Profile out for Public Comment

On January 31, 2007, the National Institute of Standards and Technology (NIST), in conjunction with the Federal IPv6 Working Group (IPv6WG) and OMB, released a Federal government IPv6 standards profile, *NIST Special Publication 500-267*. NIST is soliciting feedback on the profile through a 30-day public comment period. The comment period closes at 5:00 PM EST, on March 2, 2007.
