Dear Ms. Webb:

Chicago Mercantile Exchange ("CME" or "Exchange") hereby notifies the Commission of the following amendments to Rule 260A01.J. **Exercise Prices**. Currently, the exercise price interval for Russian ruble options is \$0.0025. As shown in the attached Appendix 1, the new exercise price interval will be \$0.00025.

This change will be implemented on Tuesday, February 3, 2004 upon notification to shareholders and members. The Exchange certifies that these actions neither violate nor are inconsistent with any portion of the Commodity Exchange Act or of the rules thereunder.
