STATE, LOCAL OFFICIALS, ADVOCATES, PARENTS AND SERVICE PROVIDERS MEET AT REGIONAL OSEP-SPONSORED INSTITUTES TO LEARN MORE ABOUT IDEA'97

Six Office of Special Education Programs(OSEP)-sponsored Institutes, each covering one of 3 topics: Assessment, Individualized Education Plans (IEPs)/General Curriculum and Positive Behavioral Supports (PBS), were held in six sites around the country in late August and September. OSEP-sponsored technical assistance providers were primarily responsible for developing and presenting the agenda. Assistant Secretary Judy Heumann and OSEP Director Tom Hehir opened each presentation by way of videotape. OSEP Special Assistant, JoLeta Reynolds shared information about changes in the law, while the technical assistance providers shared best practices information. Each Institute was well-attended (over 150 individuals at each site) and gave each participant an opportunity to engage presenters and obtain in-depth materials on these topics. All six Institutes scheduled time for participants to meet as "State Teams" and create plans for sharing information throughout their State. At several sites, State Teams had the opportunity to share their plans with other teams. The OSEP-sponsored Regional and Federal Resource Center Network was the chief coordinator of each event. Institute sites were as follows: Fort Lauderdale (IEP/General Curriculum); Kansas City (PBS); Boston (Assessment); Los Angeles (IEP/General Curriculum); New Orleans (Assessment); and Columbus, Ohio (PBS). Each State Director and Parent Training Information Center have obtained a copy of the materials presented on all three topics.
