### **Acting Assistant Attorney General Announced for OJP**

On January 21, 2005, the U.S. Department of Justice announced that Tracy A. Henke will serve as the Acting Assistant Attorney General for the Office of Justice Programs (OJP), replacing Deborah J. Daniels who served as OJP's Assistant Attorney General since her Senate confirmation on September 21, 2001. Ms. Henke joined the Office of the Associate Attorney General in October of 2003 to advise and assist the Attorney General and Deputy Attorney General in formulating and implementing Departmental policies and programs on a broad range of civil justice, federal, and local law enforcement and public safety issues. Ms. Henke also provides oversight to several Justice Department components including the Office of Violence Against Women, and the Community Oriented Policing Services (COPS) Office. Prior to the Department of Justice, Ms. Henke served as the Senior Policy Advisor for U.S. Senator Kit Bond of Missouri, and also worked for Senator John Danforth after graduating from the University of Missouri-Columbia. Known for her highly experienced and effective approaches to law enforcement and criminal justice issues, BJA welcomes Acting Assistant Attorney General Henke to OJP.

Pennsylvania Department of Military and Veteran Affairs Clandestine Methamphetamine Training. The PA Department of Military and Veterans Affairs conducts Clandestine Meth Training through a partnership with its Northeast Counterdrug Training Center and Lebanon Valley College. The goal: to educate local law enforcement in the proper use of equipment and chemical identification as well as personal and environmental safety relating to locating and investigating meth labs. During the first year alone, 120 officers participated in the in-depth training.
