### **CROP REVENUE COVERAGE**

The following 2008 CY **harvest prices** have been approved for CRC corn, grain sorghum, and soybeans in counties with a cancellation date **prior to** March 15 and for CRC rice counties with a January 31 cancellation date.

Corn	\$5.49/bu.
Grain Sorghum	\$5.14/bu.
Soybeans	\$12.79/bu.
Rice	\$0.170/lb.
