

# ORDER 12-215

## SPECIAL RESTRICTIONS

### CAVE CREEK COMPLEX WILDFIRE TONTO NATIONAL FOREST

**Pursuant to 16 USC 551, 36 CFR §261.50(a) and (b)**, the following restriction and prohibitions are established within the specific areas of the Tonto National Forest, in the State of Arizona, contained within portions of the following: T. 10 N., R. 4 E. Sections 1, 2, 3, 4, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35 and 36; T. 10 N., R. 5 E. Sections 7, 8, 17, 18, 19, 20, 27, 28, 29, 30, 31, 32, 33, and 34; T. 9.5 N., R. 4 E. Sections 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, and 36; T. 9.5 N., R. 5 E. Sections 19, 21, 22, 27, 28, 29, 30, 31, 32, 33 and 34; T. 9 N., R. 3 E. Sections 1, 2, 10, 11, 12, 13, 14, 15, 16, 21, 22, 23, 24, 25, 26, 27, 28, 33, 34, 35 and 36; T. 9 N., R. 4 E. Sections 1, 2, 3, 7, 8, 9, 16, 17, 18, 19, 20, 21, 28, and 29 in the State of Arizona, as shown on the attached map, which is hereby incorporated as a part of this Order:

**It is prohibited to be on any road or motorized trail with motor vehicles on any of the above described lands which are closed for resource protection due to the Cave Creek Complex Wildfire. 36 CFR§ 261.53 (b,c) & 36 CFR§ 261.54 (e).**

**It is prohibited to be in the 7 Springs Campground, CCC Campground and Cave Creek Group Site between the hours of 10 p.m. and 6 a.m. due to health and safety of the public created by the wildfire. 36 CFR§ 261.53(e).**

These restrictions are in addition to those prohibitions enumerated in Subpart A of 36 CFR §261 and other Forest Orders pertaining to the described lands.

Pursuant to 36 CFR §261.50(e), the following persons are exempt from this order:

1. **Persons with written authorization by a Forest Officer, which specifically authorizes the otherwise prohibited act. The Issuing Officer may include such conditions as are considered necessary for the protection of the area, or for the promotion of the health, safety, or welfare of its users.**
2. **Any Federal, State, or local Officer in the performance of an official duty.**
3. **Persons operating motor vehicles on the following National Forest System roads; 16, 19, 24, 37, 41, 44, 205, 205A, 246, 269, 468, 562, 599, 602, 612, 404, 3152, and 3206.**

This order becomes effective at 8:00 a.m. on September 6, 2005 and will remain in force until rescinded
