

CRP ENROLLMENT ACTIVITY AND NEWS – October 2008

- Enrollment of land in the State Acres for Wildlife Enhancement (SAFE) initiative has reached 85,000 acres, including 78,000 acres of grass plantings (page 23).
- Sign-up 36 (FY 2008 continuous sign-up) added 38,000 acres in October and now stands at 357,000 acres, compared with last year's 433,000 acres through October 2007, and is currently projected to end at 400,000 acres.
- Land currently under contract, 33.57 million acres, is down 1.06 million acres from last year's 34.63 million acres (page 17).
- Results of 2006's re-enrollment and extension (REX) offer for general sign-up contracts originally set to expire between 2007 and 2010 show contracts on 23.0 million acres, 83 percent, of the 27.8 million eligible acres will be extended or re-enrolled under new contracts. See p.14 for details.
- The new contract expiration schedule is provided (pages 15 and 16). It shows the 2.5 million acres that expired September 30, 2007, and the 1.2 million acres that expired September 30, 2008. Some of these lands have been re-enrolled as continuous sign-up practices.
- Results of Emergency Forestry CRP signup have been updated (page 3). There are now 259,000 acceptable acres with total rental payments of \$75 million.

General Signup. Producers with eligible lands compete nationally for acceptance based on an environmental benefits index (EBI) during specified enrollment periods. Producers may submit offers below soil-specific maximum rental rates and select wildlife-enhancing vegetative covers to increase EBI ranking.

Continuous (Non-CREP) Sign-up. Producers with eligible lands may enroll certain high priority conservation practices, such as filter strips and riparian buffers, at any time during the year without competition. In addition to annual soil rental payment and cost-share assistance, many practices are eligible for additional annual and one-time up-front financial incentives. Land enrolled under various initiatives are included in this category.

Conservation Reserve Enhancement Program (CREP). Under CREP agreements, Federal/State partnerships, implement projects designed to address specific environmental objectives through targeted CRP enrollments. Sign-up is held on a continuous basis, general sign-up practices may be included, and additional financial incentives are generally provided. Currently, there are 41 agreements in 31 States.

Farmable Wetland Program (FWP). Producers enroll small non-flood plain wetlands under modified continuous sign-up provisions.

The accompanying tables are based on contract data developed and maintained in CRP data files by USDA Service Centers through October 31, 2008, and are based on the physical location of the CRP contracted land. Some adjustments have been made to correct mis-coded data in the active contract files.

Note: Contracts re-enrolled under 2006's re-enrollment and extension offer (REX) are not considered to expire when the current contracts expire, because new contracts will begin immediately after expiration.
