Donate to the Multinational Species Conservation Funds

How does the U.S. Fish and Wildlife Service use funds that are donated to the Multinational Species Conservation Funds?

The funds you donate will go directly to projects that conserve and protect the species that you designate in the Multinational Species Conservation Funds. These include African Elephants, Asian Elephants, Rhinoceros, Tigers, Marine Turtles, and Great Apes. Projects support the protection, conservation and management of these species and their habitats, through grant programs administered by the U.S. Fish and Wildlife Service under statutory authority of the African Elephant Conservation Act of 1988; the Asian Elephant Conservation Fund of 1997, the Rhinoceros and Tiger Conservation Act of 1994, the Great Ape Conservation Act of 2000, and the Marine Turtle Conservation Act of 2004. Each of the five acts authorizes the acceptance and use of donations to help support the programs.

What will my donation be used for?

Funds for approved grant projects are typically used for conducting surveys, monitoring, anti-poaching measures, public awareness campaigns, resolution of human-species conflict, habitat protection, conservation capacity building, and applied research (genetics, behavioral ecology). Most projects have a local or regional scope, and are performed in species range countries by diverse local and international partners.

Partners match grant dollars, making any contribution to these programs compound the effect of funds provided through taxpayer funded appropriations or additional donations. Talk to your tax advisor about making a contribution to support these programs – it may be deductible. It will definitely contribute to the conservation of these heritage species.

How do I make a donation?

We cannot accept cash or credit card payments. If you wish to contribute, please ensure that the payee on your check or money order reads, "U.S. Fish and Wildlife Service". Please also designate which of the Conservation Funds is to receive your donation so it is used according to your wishes. Each donor will receive a written acknowledgement of the donation.
