The Global Development Alliance becomes an Independent Office--The Office of Global Development Alliances

USAID's Chief of Staff announced on December 13, 2005: "The Global Development Alliance Secretariat has made significant advancements in mainstreaming the GDA business model. Over the past several months, Senior Staff and many Mission Directors have participated in discussions to help determine the best possible long-term fit for GDA within USAID." He went on to say, "The consensus reached from these discussions is that the GDA Secretariat should continue to exist in order to foster the model of public-private alliance building within USAID, and to better promote outreach efforts to the private sector. As a result, the Global Development Alliance Secretariat has been approved by the Administrator to become an independent office at USAID. It will now be known as the Office of Global Development Alliances (GDA). GDA will continue to report directly to the Director of GDA, Dan Runde."

This change of status reflects USAID's commitment to public-private alliances and utilizing the partnerships as a tool for helping USAID achieve its development objectives. The name of the office has officially changed-from "Global Development Alliance Secretariat" to "The Office of Global Development Alliances"- but our commitment to serving the mission and operating units remains the same.

Public Private Alliances in the 2005 USAID's Annual Awards Ceremony

The Balkan Trust for Democracy Alliance (BTD) was the winner of this year's Global Development Alliance Excellence Award. The BTD's funding partners: the German Marshall Fund, the Charles Steward

Mott Foundation, USAID, the Government of the Netherlands, the Government of Greece, the Government of Sweden and the Rockefeller Brothers Foundation sent senior representatives to celebrate this achievement. The \$30 million BTD (of which only \$10 million is from USAID and over \$15 million is from private foundation money) was recognized for its outstanding alliance building, strong corporate citizenship, and innovative non-profit work to bring the benefits of democracy to the Balkan region.

Lane Smith, Information and Communication Technology Advisor USAID/Afghanistan, was awarded the Global Development Leaders Award "For [his] vision and creativity in developing alliances in post-conflict settings and for the energetic championing of public-private alliances in information and communications technology." http://www.usaid.gov/our_work/global_partnerships/gda/showcase/BalkanTrustFund.pdf

Plumpy'Nut-Chiponde Alliance

Plumpy'Nut-Chiponde Alliance

The Plumpy'Nut-Chiponde alliance supports a partnership between USAID and Nutriset, a French forprofit company known for their nutritional solutions provided to humanitarian relief programs. Nutriset works in coordination with Project Peanut Butter, a newly established Malawian non-governmental organization (NGO), to support a local production facility in Malawi to prepare Plumpy'Nut-Chiponde. Plumpy'Nut-Chiponde will be used for home-based treatment of malnourished children and for nutritional supplementation of HIV-infected adults and children receiving anti-retroviral (ARV) therapy.

Ready-to-use food (RUTF) is a recent major advance in the treatment of malnourished populations. In a controlled trial conducted during the 2003 famine in Southern Africa, recovery rates of children receiving RUTF-based home therapy were 79%, compared to 46% for children receiving upgraded standard milk-based feeding regimens. RUTF is a lipid rich paste of peanut butter, milk powder, and micronutrients, with nutritional content similar to the therapeutic milk F-100. It does not need cooking and does not spoil for several months at ambient, tropical conditions. In Malawi, RUTF has been produced locally on small scales since 2002, using locally available ingredients, sold under the name "Plumpy'Nut-Chiponde".

The production facility can be operated by 2-4 employees, with a production capacity of 3 tons/week. After 2 years the production capacity will be increased to 10 tons/week through new machinery. This amount should be enough to support projects working to feed over 15,000 severely and moderately malnourished children, as well as approximately 30,000 people who will begin ARV therapy.

Partners in this alliance include USAID, Nutriset, Project Peanut Butter (PPB) a Malawian NGO, UNICEF and WFP.
