Lifeworks – General Motors Joins the Fight Against HIV/AIDS

On June 14, 2006, General Motors East Africa signed an agreement with the United States Agency for International Development (USAID) mission in East Africa and Family Health International to form an innovative alliance aimed at addressing the problem of HIV/AIDS through job creation. The new partnership, called *LifeWorks*, will strengthen the economic capacity of economically-vulnerable women and orphans who reside in communities surrounding truck stops along transport corridors. Bill Lay, the Managing Director of General Motors (GM) will co-chair the *LifeWorks* Partnership Business Advisory Council that will provide business expertise to the partnership. GM staff will train targeted groups in strategic planning and business skills at a total cost of about \$240,000 over four years, and USAID will match this amount.

ExxonMobil Supports President's Malaria Initiative

The Angolan Government recently launched a child health initiative designed to benefit over three million children under the age of five by providing protection against diseases such as measles, polio, and malaria. As part of the malaria prevention efforts, over half of the 800,000 bed nets to be distributed were financed with contributions from a partnership between the President's Malaria Initiative and ExxonMobil.

USAID/Russia Launches Incentive Fund

The Russian Mission of USAID invites interest from prospective partner organizations to form Development Alliances and carry out activities in support of the USAID/Russia's development objectives. Alliance partners are expected to bring significant new resources, ideas, technologies, and/or partners to address development problems in the areas where USAID/Russia is currently working. Partners could include a wide range of organizations. Private Sector Approach embraced by multiple Development Agencies USAID and the French aid agency (Agence Française de Développement) have partnered with the United Nations Development Program (UNDP) to examine and encourage the role that business can play in accelerating economic growth and development. In 2004, UNDP explored this agenda in its report, *Unleashing Entrepreneurship: Making Business Work for the Poor.* UNDP now hopes to build on this work and identify how business can contribute to the Millennium Development Goals, by reviewing the experience of companies developing commercial business models driven by market incentives, and as part of a corporation's business strategy, which also has strong implications for development.
