Enrollment for participation in the 2005 Direct and Counter-Cyclical Program ended June 1, 2005. Late-filed enrollment ended September 30, 2005.

The 2002 Farm Bill establishes the 2005 direct payment rates and mandates that 2005 DCP direct payments not be issued prior to October 1, 2005. However, eligible producers have the following options for receiving advance payments:

- Producers were given the opportunity to elect an advance payment payable at 50 percent of the final direct payment rate beginning December 1, 2004.
- Producers could select the month in which they wished to receive the advance payment.

COUNTER-CYCLICAL PAYMENT INFORMATION

If the Secretary determines counter-cyclical payments are required, the 2002 Farm Bill allows producers to receive 2005 DCP counter-cyclical payments in three installments:

- The 1st partial payment is payable at up to 35 percent of the projected payment rate for the covered commodity.
- The 2nd partial payment is payable at up to 70 percent of the total projected rate for the covered commodity minus the amount received through the first partial payment.
- The final payment is payable after the end of the 12-month marketing year for the covered commodity minus the amounts received through the 1st and 2nd partial payments.
