



## USDA Agricultural Outlook Forum Student Diversity Program Sponsorship

USDA's Outlook Forum Diversity Program has created a sponsorship opportunity for agencies, corporations, and organizations. This program sponsors between 15-18 students to attend USDA's annual 2-day event, promoting participation that will educate students about agribusiness, the latest research, future trends, and policy in contemporary agriculture. These students represent the diversity of American agriculture and are hopefully among the next generation of agricultural industry leaders.

**Sponsorship:** The 2010 Agricultural Outlook Forum will be held February 17-18, 2010, in Arlington, Virginia, at the Crystal Gateway Marriott Hotel. USDA's World Agricultural Outlook Board and Cooperative State Research, Education, and Extension Service (CSREES) will provide the students with complimentary registration. Partnering sponsors will provide expenses for lodging, meals, and transportation for the students from their college or university to Washington, D.C., arriving February 16, 2010, and returning home February 18, 2010. **Selection Criteria:** The Diversity Program targets agriculture, agricultural economics, agricultural communications, agricultural business, or pre-veterinary junior or senior undergraduate students. Participating Land-Grant Colleges and Universities will submit a letter of recommendation from the Dean of the Agricultural Department for up to two students per school along with the student's one-page essay titled "Agriculture as a Career." A CSREES panel provides an initial review of the submissions. Final selections will be made by Lisa Purnell, USDA Liaison Officer, University of Maryland Eastern Shore (UMES). Two positions are reserved for UMES students.

**Travel Itinerary:** Participating students will receive a USDA briefing, and learn about the history of the Forum as well as the current topics. On Wednesday evening, February 16, 2010, students will register for the Forum and attend an informal gathering at the Marriott Hotel. Thursday and Friday they will attend the Forum sessions, including the Thursday evening dinner-lecture session.
