While templates, checklists, or agreements developed for purposes of compensatory mitigation for the Corps Regulatory Program need to comply with the mitigation regulations, the regulations also provide substantial flexibility for districts to account for regional differences in aquatic resource types, functions, and services. There are also legal considerations that vary among the various government jurisdictions (e.g., real estate and fiscal laws and ordinances) that may affect the content of templates or agreements. An instrument developed in one District or state may not be applicable in another.
