A EMS SSMC Facility Team meeting was held by those members available on short notice to review any last-minute preparations for the scheduled 2008 internal EMS audit of the NCCOS SSMC Facility on Monday, June 23, 2008. Items discussed were 1) how team members would remind their respective offices (i.e., CSCOR, CCMA and NCCOS Hqtrs.) of the upcoming audit (i.e., JW would use a Thursday staff meeting and a follow-up e-mail; TG and TD would utilize e-mails; and 2) the reminders would include, among others, mention of possible interviews, familiarity of the NCCOS EMS website and NCCOS EMS policy statement; awareness of the 5 EMS "Spotlights" and 2 EMS "Eco-Notes;" use of personal appliances; and names of the NCCOS, SSMC and Facility Team representatives. The local team members would make themselves available during the audit.

There was agreement among those EMS SSMC Facility Team members in attendance that the NCCOS EMS effort should communicate clearly and succinctly, focusing primarily on what concrete steps people can take and less emphasis on compliance directives and goal achievement milestones.
