In order to confirm eligibility, potential 105 applicants should check with the 105 grant coordinator in their agency who will contact the appropriate EPA Regional Grant Coordinator listed in Section III, B, of the Request for Proposal EPA-OAR-TRPD-07-09. EPA makes the final eligibility decision.

- Q2: Which Agency is responsible for determining eligibility?
- A2: Only EPA has authority to determine eligibility under this RFP.
- Q3: What amount of funding is available through this competition?
- A3: Approximately \$549,000 (amended from original RFP)
- Q4. How do we determine if a match would be required?

A4: Applicants are advised to submit projects as non-recurring – a one time project. This minimizes or eliminates the possibility that a match would be required. However, to determine whether your project would require a match, EPA advises applicants to contact

their agency grants manager responsible for Section 105 (STAG) funding. If necessary or helpful, that contact can be in touch with the appropriate EPA Regional Grant Coordinator, listed in Section III, B, of the Request for Proposal, EPA-OAR-TRPD-07-09.

Q5: Are nonprofits, academic institutions, or municipal governments eligible to apply?

A5: As stated in RFP-OAR-TRPD-07-09, Eligible Entities are those who currently receive direct section 105 funding (list provided in OAR-TRPD-07-09 Amendment 1). Only state, local and tribal agencies air management agencies as designated under the Clean Air Act are eligible to apply directly for this funding. However, other organizations interested in undertaking mobile source-related outreach projects are encouraged to forge a partnership with an eligible agency (see list in Q1)

Q6: Does this competition allow for purchase of cars for alternative transportation projects?

A6: The intent of this competition is to provide seed money to outreach projects which can be developed and handed off to other communities. For that reason, purchasing a car to benefit one community would not be considered eligible under this RFP.

- Q7: Where can we access EPA's National Strategic Plan?

Q8: Are the funds eligible for the education and outreach, or can the funds be applied to a project that will include informational/market outreach to various stakeholders through webcasts, emails, trade shows, and our web site.
A8: These activities may be eligible if submitted by an eligible air management agency. (See Q1 above for list of eligible agencies)

Q9: Does a truck stop laboratory qualify as it will define environmental best practices to reduce and report on greenhouse gas emissions?

A9: As written in the RFP, Section III.A., "Eligible Entities", only current direct recipients of CAA Section 105 grants are eligible to apply for this competition. (See Q1 above for list of eligible agencies).

Q10: Is there a public list of public stakeholders EPA might suggest for partnership on this RFP? We are thinking DOTs, towns,Clean Cities coordinators and Climate Change organizations. Would these be possible candidates?A10: Please see the list of eligible agencies in Q1 above.

Q11. Section II F states:

"Successful applicants cannot use subgrants or subawards to avoid requirements in EPA grant regulations for competitive procurement by using these instruments to acquire commercial services or products from for-profit organizations to carry out its assistance agreement." Does this mean private sector firms cannot partner with public entities?

A11: A private sector firm could partner with an eligible entity through a contract.

Q12: Page 4, Section II F. Funding to Acquire Services or Fund Partnerships

Our reading of this indicates that we could issue sub-grants. Will going thru a recipient agency's procurement process for sole source award meet this requirement or would we have to put out a competitive bid?

A12: Grant and cooperative agreement recipients are responsible for selecting their subrecipients (subgrants) and conducting their subaward competitions. A recipient agency would follow their State law and procedures when selecting, awarding and administering their sub-grants.

Q13: Page 5, Section III B. Cost Sharing or Matching

Can a recipient's match be in kind (staff salary/time) or does it have to be is actually dollars supplied? Are we correct in calculating that a 40% match of a 100K grant would be $100/60 \times 40 = 66$ K? Would this match affect an agency's other match commitments? A13: Yes. A recipient agency's match can be in-kind (staff salary/time). In-kind match should be clearly documented in order to clearly distinguish and account for the in-kind resources attributable to the mobile source work. The Clean Air Act Section 105 only requires agencies to contribute enough dollars to maintain the overall match of 40%. The MOE pertains to recurrent (continuing) program activities and expenditures only - not to non-recurrent (one-time singularly unique) expenditures. The only way the an agency would have to continue to spend its increase in contribution was if it was necessary to maintain a minimum 40% share relative to the whole CAA Section 105 program amount.

- Q14: Can an eligible agency submit more than one proposal?
- A14: Yes, so long as each proposal presents a totally different project.

Q15: Is it mandatory for proposals to be submitted through "grants.gov?"

A15: No. Section IV C of the RFP - Application and Submission Package, Submission Requirements" states that "you may choose to apply under this announcement in one of two ways. Although EPA encourages applicants to submit their application/proposal materials electronically through "http://www/grants.gov", you may wish to submit hard copy." If you wish to apply with a hard copy submission, please see part D.2.

Q16: Must the proposal due by August 31 include the actual paperwork to provide funding to a subgrantee or contractor?Q16: No. The RFP calls for applicants to indicate when funding would be shared through a grant or contract. If selected, an agency must follow all the processes and procedures applicable to that agency which ensure full and open competition.
