## Top Lenders of 7(a), 504 and Export Loans Honored by SBA; Surety Bond Lender Also Recognized

WASHINGTON, D.C. - Seven banks and other lending institutions from California, Pennsylvania, Florida, Virginia, Texas, and Rhode Island were honored today for their outstanding small business lending practices by the U.S. Small Business Administration, during an evening reception at the Department of State in Washington, D.C., as part of the Small Business Week 2006.

The event, which this year runs from April 12-13, honors State Small Business Persons of the Year from all 50 states, the District of Columbia, Guam and Puerto Rico, and recognizes businesses recovering from natural disasters, people who have helped others recover from natural disasters, small business lenders, small business contractors and contracting officers, and advocates for small businesses.

The awards to lenders were presented by SBA Administrator Hector V. Barreto. The 7(a) Loan Lender of the Year was split into two sub-categories: large lender for banks with an outstanding SBA loan portfolio of $\$ 100$ million plus, and small lender for a portfolio of less than $\$ 100$ million. The Large 7(a) Loan Lender of the Year Award went to Center Bank of Los Angeles, California. The Small 7(a) Loan Lender of the Year Award winner was The Legacy Bank of Harrisburg, Pennsylvania.

Also honored were two -large and small- Certified Development Companies, or 504 Lenders. The Large 504 Loan Lender of the Year was the Florida Business Development Corporation of Orlando, Florida. The Small 504 Loan Lender of the Year Award went to the Rappahannock Economic Development Corporation of Fredericksburg, Virginia.

As exports are playing an increasing role in growing the American economy, so is export lending. Two export lenders honored by the SBA with its Export Lender of the Year Award this year were Innovative Bank of Oakland, California, and Citizens Financial Group or Warwick, Rhode Island. Finally, as a first time entry this year, the SBA is recognizing a Surety Bond Lender. The Surety Bond Lender of the Year Award winner is the Western Surety Company of Houston, Texas, a subsidiary of CNA Surety Companies, a firm that provides for a full range of bonding needs in all 50 states.
"As any small business owner will tell you, financing is the bread and butter of any successful small business," said Barreto. "But it is not only money and terms, as important those are, it is the support you get from your financial institution, and these honorees have been outstanding in their
dealings with their small business customers in their communities. We are proud of our partnership with them in helping small businesses to succeed and to present them with these awards in recognition of their excellence."
