Notice of Implementation of the Arid West Supplement to the 1987 Corps Wetland Delineation Manual/Training

For the State of Oregon

Issue Date: December 20, 2006 *Revised Date: January 12, 2007

*The original public notice dated December 20, 2006 has been revised to explain historic Corps guidance superseded by the Supplement. Those documents are listed in the highlighted portion that follows.

The U.S. Army Corps of Engineers, Portland District (Corps) and the Oregon Department of State Lands (Department), jointly announce the publication and implementation of the Arid West Interim Regional Supplement (Supplement) to the Corps' 1987 Wetland Delineation Manual (1987 Manual). The Supplement was developed by wetland delineation experts from state and Federal agencies and academia with experience within the arid western United States. It has been peer reviewed by an independent panel of western scientists and practitioners. This interim document will be tested for a one year period prior to finalization; this one year period will begin effective 30 days from the date of this public notice. An interagency team is planning to hold orientation sessions to help interested parties within the States of Oregon, Idaho and Washington become more familiar with the Supplement. The sessions are not a complete training in doing wetland delineation, but only an update on changes in the Supplement. One session, specifically for state and Federal agency personnel, will be held on February 13, 2007; a second session for consultants and other interested parties will be held on February 14, 2007. See Appendix A for information and registration regarding those training sessions.

Effective 30 days from the date of this public notice, the Supplement data forms and indicators must be used for any data collection for wetland delineations. Field data collected for wetland delineations using the 1987 Manual prior to the effective date of this notice, but not yet submitted for review and formal approval, will be grandfathered. Documentation must be submitted which clearly shows the field data was collected prior to 30 days from the date of this notice in order to qualify for this grandfather provision. Once this documentation has been reviewed and approved by this District and the Department under the 1987 Manual, a written jurisdictional determination will provided.

*The following guidance is superseded by this Supplement, and is hereby rescinded by this public notice:

"Implementation of the 1987 Corps Wetland Delineation Manual," memorandum from John P. Elmore dated 27 August 1991.

"Questions & Answers on the 1987 Manual," memorandum from John F. Studt dated 7 October 1991.

"Clarification and Interpretation of the 1987 Manual," memorandum from Major General Arthur E. Williams dated 6 March 1992.

"Revisions to National Plant Lists," memorandum from Michael L. Davis dated 17 January 1996.

"NRCS Field Indicators of Hydric Soils," memorandum from John F. Studt dated 21 March 1997.

While we are confident the Supplement will improve the accuracy of wetland delineation in Arid West, anyone performing a wetland delineation during this interim period using the Supplement who believes it has resulted in a significantly different boundary line than the 1987 Manual may also complete the delineation using the 1987 Manual and submit both delineations. Enough data points to adequately describe the representative plant communities, soils, and hydrology of the site(s) and to clearly document the difference in boundaries between the two methods must be included. Data recorded on both the existing data forms and the new Supplement data forms, maps indicating the location of the field site and data collection points (upland and wetland), and a completed field evaluation questionnaire for each delineation must be submitted as part of the jurisdictional determination request to this District Office and to the Department. The District and the Department will make the final determination for Federal and state purposes, respectively, based on analysis of all the submitted information. This information will also be used in evaluation and potential modification of the Supplement.
