This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. During high rainfall events and/or the winter rainy season, would expect some flow between wetlands that are proximal to one another e.g., R&S, O&Q, P&Q; further, much of Wetland Q is configured as a ditch, so it would be expected to be at least ephemeral in nature and potentially intermittent given the proximity of the groundwater table to the surface (at 1 foot).

Characteristics: Generally no surface flow in all wetlands except Wetland Q; during high rainfall events and/or the winter rainy season, would expect some sheet flow within the wetlands and some discrete flow between wetlands that are proximal to one another. Because Wetland Q is configured as a ditch and as polygonal wetlands, one would expect both discrete and sheet flows, respectively, particularly during high rainfall events and/or the winter rainy season.

Summarize overall biological, chemical and physical functions being performed: All wetlands considered here constitute a complex within the former floodplain of the Columbia River. The Berry Farm Ditch and its extension (i.e., the linear portion of Wetland Q) ecologically link this complex to the Columbia River. The wetlands provide a mosaic of wildlife habitats, provide the potential to filter pollutants, capture stormwater, recharge the aquifer associated with the TNW, and provide food chain support for both the immediate receiving water (i.e., Salmon Creek) and the TNW, Columbia River.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

The Ditch and wetlands T & X are located in close proximity to an agricultural operation that could reasonably deliver fertilizers, sediments, and pesticides to Salmon Creek and subsequently to the TNW. On the other hand, all other 6 wetlands are well vegetated with significant vegetated buffers, together which provide the potential to filter any area pollutants and reduce or prevent their entry into the TNW. Likewise, these 6 wetlands most completely function to capture and store stormwaters, allowing for its slow release to the groundwater. They also function to deliver nutrients and organic materials to help support downstream foodwebs as well as to support populations of herpetofauna and avifauna and downstream fisheries. The E-W Berry Farm Ditch, in combination with its adjacent wetlands, provide more than an insubstantial effect on the physical, chemical, and biological integrity of the TNW.
