Greetings:

Re: Codex Alimentarius 'Guidelines'

I am writing to protest the above guidelines.

To protect the interests of the pharmaceutical industry in their purely symptom-oriented and often dangerous drugs, my right of access to effective vitamin/mineral/herb therapies and natural treatments, together with my fundamental right to health and well-being, are being seriously violated. The Codex 'guidelines' will artificially sustain the markets for now **superfluous** pharmaceutical drugs at a time when more and more widespread diseases and public health problems **can** be successfully combated by vitamin/mineral/herb and other natural therapies **free** of side-effects.

I am aware of research, including Dr Rath's, that vitamin deficiency is shown to be the **cause** of most widespread health problems of our time. Also the saving of thousands or millions of human lives is partially dependent on how quickly life-saving information about the health benefits of vitamins and other natural therapies **can** be spread.

This makes all legislative efforts to censor or ban the spreading of natural health information knowledge and/or products all the more unethical and contemptible. Censorship laws or 'guidelines' do not (contrary to arguments by the pharmaceutical/medical industry) protect consumers from alleged side-effects. What it does is allow **thousands** of people to die every year from the **harmful** side-effects of pharmaceutical drugs by prescription. In fact for instance, the deadly side-effects of cholesterol-blockers and other pharma-drugs have become the fourth most common cause of death in the industrialized world (surpassed only by heart attack, cancer, and strokes)!

As a political decision-taker supporting these laws you **are** knowingly risking the unnecessary deaths of citizens of our country. Censorship forced upon us by such avenues **as** the Codex 'Guidelines' is unscrupulous and **unfair**, and even more **so** when **there** is no public discussion **or** publicity and when it is against the express will of the people of this country—no democratic process. It is even more appalling when we see in the newspapers that the EU Commission (involved in the Codex process) was dismissed by the European Parliament for corruption and for taking bribes from multinational companies.

I realize that I must take responsibility for my **own** health, and it is much more important than the **share** prices of a handful of pharmaceutical industry speculators.

Please take action/vote to stop the Codex Alimentarius **and** the EU Directive on dietary supplements and related censorship laws or guidelines on the national and international level. In fact I would **ask** that you openly support unrestricted access to information about the health benefits of **botanical** therapies and other natural treatments **as** a basic human **right**. **Also** please support dietary supplements (vitamins, minerals, herbs, plants) **as** foods and not **as** a category under drugs or under pharmaceutical **access** to control.
