Recently someone told me that the US government practices Satanic Rituals. If I didn't know what was going on in slaughterhouses across this country I would have laughed it off-but in fact, processing animals alive, as workers have gone to great lengths to provide evidence thereof, is akin to Satanic Ritual. And it has got to be stopped FOREVER!

I have been assurred by the FSIS for the last three years that the Humane Slaughter Act is upheld rigoriously. But how do you know? Are you there to safeguard every animal before it is hoisted on the chain? Is the vet? What happens when he must go to the bathroom? Does the line stop? How long is the vet watching the stunner? All day -half a day? Workers say its not alot. Workers say it is still going on and that nothing much has changed. They proved it once with video cameras through a Humane organization. Why didn't the FSIS do its job and prove it? Why is it still going on? These are questions I ask my listeners. People see my show all over the world. They see other shows as well and hundreds of letters have been written on behalf of petition 02-02. Yet nothing happens and the diabolocal behavior goes on.

Part of the problem, I am told is money. There just isn't enough money to hine full time inspectors to be watching each animal as it is stunned and put on the chain. So, here is a solution and one that doesn't cost any more money. The stunner is allowed to stop the chain and restun an animal or call in the vet to do the euthenizing if the animal is thrashing about in agonized convultions. The video camera is the verifiable witness. (ameras do not lie. People do. The camera will watch the animals on the chain and the stunner and this footage is reveiwed in a spot check program by the FSIS and the General Accounting Office to make sure everyone is doing their job. The video camera is paid for by the plant and that cost is passed onto the consummers. It shouldn't cost more than a nickle more a pound if that. If a plant has disobeyed the law as witnessed through the footage their suspended. Knowing this will greatly reduce line speed and keep plant managers off the backs of the stunners. The stunners will know they too will loose their job if they don't stun the animal properly and stop the line when nescessary to do so.

If slaughter plants and the meat industry believe that slower line speed with reduce income it is nothing compared to the coming wave of people sickened as I am who have given up meat and dairy altogether and millions more reducing their intake until they are assurred the Humane Slaughter Act is enforced with a verifiable witness program. This coupled with the mad cow disease and the newer strains found in Italy.

Please, Dr. Dickey, implement a verifiable witness program NAW! Its been three years and your agency has done nothing towards this important humane step. And yet, almost immediately you took steps to deal with the mad cow scandel.

You can move fast when you need too. You have the power to make these suggestions possible.

I enclose a letter sent to all my Senators, (ongressmembers calling for a (ongressional Investigation as to why there is not a verifiable witness program to uphold the Humane Slaughter Act.

Listeners from all over the world come to Monterey and they hear my story of how our government allows this to go on and on. If you think God will have any pity on a nation that allows such torture to endure, you better think again. Your soul and anyone elses eating of this meat will bring itself to justice. Dear Ms. Griffin:

Thank you for your recent telephone call to the Food Safety and Inspection Service (FSIS) about the placement of video cameras in livestock slaughter establishments to monitor compliance with the Humane Methods of Slaughter Act (HMSA).

As Dr. Daniel L. Engeljohn stated in previous letters to you, regulations that enforce HMSA do not require that livestock slaughter establishments install video cameras to monitor the handling of animals before and during slaughter. Federal regulations would have to be amended before FSIS could impose such a requirement. We also explained to you that the Agency views your request as a petition to amend Federal regulations. Your petition has been assigned the number 02-02 and has been filed in the FSIS docket room where it is available for public viewing. We also have previously sent you information about how to submit additional documentation in support of your petition.

We appreciate your continued interest in the welfare of animals raised for food.
