Subject: Healthcare Integrated General Ledger Accounting System (HIGLAS) Changes for Implementation of Stage 3 of National Provider Identifier (NPI)

I. SUMMARY OF CHANGES: In the October 2006 Quarterly release, the format of the HIGLAS 837, 810, 810 H, 811 CR, 811 VMP, and 835 interfaces between HIGLAS and the Fiscal Intermediary Standard System (FISS) and Multi-Carrier System (MCS) shared systems were changed to include data elements for the NPI and the NPI qualifier. The release also included requirements for the submission of the NPI and the NPI Qualifier by FISS and MCS on the HIGLAS 274 interface to HIGLAS.

Stage 3 of NPI requires that all electronic transactions covered by HIPAA are to contain an NPI. Therefore, with implementation of this change request, the FISS and MCS shared systems will began to send NPIs on claim, invoice, and payment confirmation transactions to HIGLAS. HIGLAS will return the NPIs to the shared systems with the payment and void data.

I. GENERAL INFORMATION

A. Background: In the October 2006 Quarterly release, the format of the HIGLAS 837, 810, 810 H, 811 CR, 811 VMP, and 835 interfaces between HIGLAS and the Fiscal Intermediary Standard System (FISS) and Multi-Carrier System (MCS) shared systems were changed to include data elements for the NPI and the NPI qualifier. The release also included requirements for the submission of the NPI and the NPI Qualifier by FISS and MCS on the HIGLAS 274 interface to HIGLAS.

Stage 3 of NPI requires that all electronic transactions covered by HIPAA are to contain an NPI. Therefore, with implementation of this change request, the FISS and MCS shared systems will begin to send NPIs on claim, invoice, and payment confirmation transactions to HIGLAS. HIGLAS will return the NPIs to the shared systems with the payment and void data.

As it is possible that a single NPI will have multiple Provider legacy numbers (Provider Identification Number (PIN) and Online Survey Certification And Reporting (OSCAR)) associated with it, there will be situations in which HIGLAS may be sending to the shared systems multiple payments transactions in the HIGLAS 835 for the same NPI. Each payment will have the same NPI but a different Provider legacy number associated with it.

It is also possible that a Provider legacy number will have multiple NPIs associated with it. Therefore, situations may exist in which HIGLAS will be sending to the shared systems multiple payments transactions in the HIGLAS 835 for the same Provider legacy number. Each payment will have the same Provider legacy number but a different NPI associated with it.

HIGLAS will continue to send and receive the Provider legacy numbers in its interfaces with the FISS and MCS shared systems.

B. Policy: The Health Insurance Portability and Accountability Act of 1996 (HIPAA) requires that the Secretary of the Department of Health and Human Services adopt standards providing for a standard unique health identifier for each health care provider for use in the healthcare system and to specify the purpose for which the identifiers may be used. The National Provider Identifier (NPI) final rule published on January 23, 2004, establishes this standard for a unique health identifier, announces the adoption of the National Provider Identifier (NPI) as that standard, and establishes implementation specifications for obtaining and using the NPI (45 CFR Part 162, CMS-0045-F). All entities covered under HIPAA must comply with the requirements of the NPI final rule no later than May 23, 2007.
