Discounts on FedEx Shipments

FedEx was awarded a Department-wide Blanket Purchase Agreement (BPA) #45-3142-4-06488 for domestic delivery services. It is expected to provide savings of at least 17% off FedEx's Federal Supply Schedule (FSS) contract. The BPA contains a base and 4 option periods ending on September 19, 2009, or the expiration of the FSS contract upon which the BPA is based (whichever comes first).

The BPA is part of the Intergrated Acquisition System e-Alliance initiative to leverage the Department of Agriculture's (USDA) buying power and is not mandatory for USDA users. The BPA is expected to save over \$2 million annually as a result of reduced rates and free packaging. USDA users will automatically get the discount beginning September 20, 2004.

The rate schedules are for USDA use and not for outside release.

Offices with existing FedEx accounts will not have to do anything to get the discounts. The new prices are loaded in FedEx's billing system and USDA users will automatically get the discounts beginning September 20, 2004. Offices without an existing FedEx account should call the FedEx representative to establish one. Next business day time-definite afternoon delivery by 3 p.m. to thousands of cities, and by 4:30 p.m. to most other areas. Monday through Friday delivery service. The service applies to letters, packages, and boxes up to 150 pounds, maximum 119" length and 165" length plus girth. Not available to/from Hawaii.

Accommodates pieces weighing 151-2,200 pounds and up to 119" in length, 70" in height or 300" in length plus girth.

FedEx 3DaySM Freight

Time-definite delivery of palletized freight generally within 3 business days by 3 p.m., in every state except Alaska and Hawaii. Accommodates palletized freight weighing 151-2,200 pounds and single pieces up to a maximum height of 70", length and width 48".

Freight Shipments

Multiple pieces tendered to FedEx Express as FedEx Express Freight shipments must be palletized, stackable, and either banded and/or stretch-wrapped or shrinkwrapped together to form single handling units. Each piece tendered to FedEx as a single unit must move from one sender to one recipient, use the same service, have the same delivery and special handling instructions, be billed to the same party and weigh 151 lbs. or more. Individual packages in a multiple-package shipment may have different weights, dimensions, and declared value amounts.

The maximum declared value for any FedEx Letter and FedEx Pak in a shipment is \$500 within the U.S. and \$100 to international destinations. For items in other packaging, the maximum declared value is \$50,000. Please refer to the enclosed Pricing Proposal for Declared Value Charges.

The declared value limit for shipments between Puerto Rico and the U.S. is US\$50,000 per shipment, rather than US\$50,000 per package. Our liability for any package shipped between Puerto Rico and the U.S. and tendered using a FedEx customer automated shipping device is limited to \$100 or \$9.07 per pound, whichever is greater. Please see the section labeled “Declared Value and Limits of Liability” on pages 5-6 in Terms and Conditions of the *FedEx Service Guide* for further details.

It is important to note that exposure to and risk of any loss in excess of the declared value is either assumed by the shipper or transferred by the shipper to an insurance carrier through the purchase of an insurance policy.
