Proposed Modifications



- Storage of containers within modular buildings or transportainers on Pad 9 at Technical Area (TA) 54, Area G.
- 2. Storage of containers that potentially contain free liquids at TA-54, Area G within Dome 231.
- Change the footprint of the container storage unit outside TA-54-38 (TA-54 West) and allow for storage within modular buildings or transportainers, temporarily in payload configurations, and within loaded waste trucks prior to transport.
- 4. Movement of modular buildings and a canopy from the north side of TA-54, Area L to the south side.





First & second proposed modifications

- Storage on Pad 9 within modular buildings or transportainers at TA-54, Area G.
 - Temperature stabilization for containers undergoing transuranic (TRU) characterization procedures.
- Storage of containers that potentially contain free liquids within Dome 231 at TA-54, Area G.
- Increases efficiency of the TRU waste characterization program.
- Does not increase the amount of wastes to be stored within the



Third proposed modification

- Footprint change for the outside container storage unit at TA-54 West.
- Allow for storage within modular buildings or transportainers, temporarily in payload configurations and within loaded waste trucks prior to transport.
- Improves efficiency, resolves transport issues, and increases the opportunity for covered storage within the bermed fenced area at TA-54-38.
- Does not increase the amount of waste that can be stored in the unit or change the types of wastes stored at the area.

Fourth proposed modification






- Movement of modular buildings and a canopy from the north side of TA-54, Area L to the south side.

- Modification is requested to be applied to LANL's permit renewal application documentation.
