FPA Executive Oversight Group (EOG) Meeting Decision Summary May 22, 2008

On May 22, 2008 a meeting convened of the FPA EOG for the Fire Program Analysis (FPA) in Washington, DC. Present were the FPA EOG members, FPA Project Leadership, bureau subject matter experts, and invitees of the bureaus or EOG members. The meeting was chaired by FPA EOG Co-chair John Phipps, USFS.

DECISION 1: The Sub-Committee will continue to refine the interagency budget process and analysis guidance. They will present a final proposal at the June 12, 2008* EOG meeting for a preliminary decision with a final decision following the IST meeting the week of June 16, 2008.

DECISION 2: FPA will include analysis of HVR in the first year's analysis <u>IF</u> nationally consistent data sets are defined for up to four of the EOG identified HVRs and the data are made available for FPA use prior to August 15, 2008. These data will not be delivered to FPA in time for the June 30, 2008 system release. Those data accepted for development by the Fire Hazard and Fire Risk project for use by FPA in the first year's analysis include: Endangered Species Critical Habitat, Energy Transmission Corridors, Air Quality-Class I Air Sheds, and Municipal Watersheds. The EOG will be involved in determining any additional HVR categories or layers of HVR.

DECISION 3: The communications team will finalize the FPA Communications Strategy for EOG approval at their June 12, 2008* meeting.

DECISION 4: The co-chairs for the Interagency Science Team will present the EOG with a draft peer review and publishing plan^{**}. This strategy will be presented for discussion at the July 8, 2008 EOG meeting.

DECISION 5: The July 8, 2008 meeting will include discussions regarding the feasibility of expanding the scope of FPA to include acres treated for reasons other than reduction of wildland fire risks.

DECISION 6: The July 8, 2008 meeting will include briefings from the Interagency Science Team on findings from the prototype FPU workshop, issues and status of model development and application, and status of HVR data set identification and definition. The EOG requested representation from the FPA MAT be present to interact with the EOG and the IST.
