Mount St. Helens New Dome Update

The eruption that began with a flurry of small earthquakes on September 23, 2004, has moved into its third calendar year. A new 876-foot high lava dome has been created at the crater surface. The new dome containing about 101 million cubic yards of material has exceeded the volume of the dome that took six years to emerge in a series of eruptions between 1980 and 1986. The current <u>eruption</u> is pumping out rock at the pace of about a <u>pickup</u> load every second.



Mulder named Mount St. Helens Monument Manager



Forest Administrative Officer Tom Mulder will succeed Cliff Ligons, who retired January 3, 2006, as Monument Manager. Mulder will take over as Manager on February 19. A 25-year veteran of the Forest Service, Mulder became Administrative Officer at the Forest Headquarters in 1997. He has helped develop a new non-profit group to support the Monument - the Mount St. Helens Institute – and has worked with Monument finances, partners and personnel issues. "Many people hold the mountain dear" Mulder said. "I am looking forward to the challenges of upholding that trust and ensuring we keep it a very special place."

FY 2006 County Payment (RAC) Projects Approved

Forest Supervisor Claire Lavendel recently approved 30 Forest-related projects totaling more than \$1.8 million: 18 projects were recommended by the Resource Advisory Committee (RAC) for the south half of the Forest valued at \$1,198,734; 12 projects were recommended by the North RAC valued at \$653,981. Work funded includes restoring watersheds, enhancing wildlife forage, removing noxious weeds, thinning trees, and road and trail maintenance. The Secure Rural Schools and Community Self-Determination Act of 2000 gives counties a payment in lieu of taxes on federal lands equal to the average of their three highest years' payments for Forest products between 1986 and 1999. Forest Decides to Remove Hemlock Dam



On December 5, 2005, Mt. Adams District Ranger Nancy Ryke signed a Record of Decision (ROD) calling for removal of the 70-year old concrete Hemlock Dam. The dam was built in 1935 by the Civilian Conservation Corp (CCC) to supply electricity for the Wind River Nursery, which closed in 1996. Implementation is expected to begin in 2007, which will allow for acquiring funding for the project. "Removing the dam and its sediment is

Wind River Canopy Crane Cam now Online

You can now visit the Wind River Canopy Crane with the click of a mouse. The crane, located in the southwest part of the Forest north of Carson, Wash., is the first of its kind in a temperate forest. The crane is just like those looming over construction sites in many major cities. The crane's gondola can be lowered in a 550-foot circle, giving researchers access to study nearly six acres
