PROMOTE AND PROTECT

Environmental Justice, often referred to as "EJ," is based on the principle that all citizens of Illinois should be protected from environmental pollution and have the right to a clean and healthy environment, regardless of their race or income level.

The Illinois EPA supports this principle by ensuring equity in the administration of the state's environmental programs, with adequate opportunities for meaningful public involvement in developing, implementing, and enforcing environmental laws, regulations, and policies.

To support this goal, the Illinois EPA created an EJ Officer position and formed an EJ Advisory Group that helped the Agency adopt a number of EJ policies, including an EJ public participation policy, internal procedures for responding to EJ concerns and complaints, and an EJ grievance procedure.

EJ GOALS

- Ensure that communities receive an equitable share of environmental protection and benefits
- Strengthen the public's involvement in environmental decision-making
- Ensure that Illinois EPA personnel use a common approach to addressing EJ issues
- Ensure that the Illinois EPA continues to refine its EJ strategy to respond to the communities it serves

EJ ADVISORY GROUP

The Illinois EJ Advisory Group consists of representatives from EJ groups, environmental groups, industry, academia, government, community-based organizations, and trade associations. The Advisory Group has provided recommendations on EJ policies and procedures adopted by the Agency, assisted with strategies to better communicate with residents in areas with potential EJ concerns, and made suggestions on how to implement Agency programs to ensure environmental justice.

ROLE OF THE EJ OFFICER

The Illinois EPA EJ Officer serves as a liaison between citizens and communities, and Agency staff. The EJ Officer coordinates and facilitates EJ activities on behalf of the Illinois EPA, with the advice of the EJ Advisory Group.

COMMUNITY OUTREACH

The Illinois EPA has developed and implemented a public participation policy that calls for enhanced community outreach when significant permitting decisions and

environmental cleanup activities are planned in areas with potential EJ concerns. Outreach activities may include community meetings, formal public hearings, distribution of fact sheets, and more.

U.S. EPA EJ GRANT PROGRAMS

U.S. EPA's EJ Collaborative Problem-Solving Cooperative Agreement Program provides financial assistance to eligible organizations working on, or planning to work on, projects to address local environmental and/or public health issues in their communities, using its "Environmental Justice Collaborative Problem-Solving Model."

The EJ Small Grants Program provides financial assistance to eligible organizations to build collaborative partnerships, to identify the local environmental and public health issues, and to envision solutions and empower the community through education, training, and outreach.
