Project Objectives:

The Full of Weeds WMA will focus this year on eradicating noxious weeds in two specific regions of the WMA Boundaries. To accomplish tasks as outlined below, the Full of Weeds WMA will be hiring two seasonal employees for these projects. WMA partners will assist the crew with the areas that will be worked. The crew will receive training regarding the safe and proper use of pesticides and GPS weed mapping procedures.

Northern Region of Full of Weeds WMA:

- I. We will survey and treat musk thistle in the Big Lake area. We will comb the area three times: (1) Early season: to treat known sites early, (2) Mid-Season: after plants bolt to facilitate detection, and (3) Late: season to treat any new rosettes from summer rains.
- II. We will survey and treat musk thistle and Scotch thistle in the Small Creek area. Over the last several years we have found some new patches that where quite dense. ATV's will be used to enhance treatment efficiency in this area.
- III. Scotch thistle and spotted knapweed are found scattered through the North Western part of Big Valley. The crew will work with WMA partners who will assist where needed in this area.
- IV. We will survey and treat dalmatian toadflax in the Deep Rock and Renton Areas during the latter part of the season. The focus will be on eradicating the infestation in the Deep Rock area where several new sites were located last year.

Southeastern Region of Full of Weeds WMA:

We will be conducting survey and treatment activities on the diffuse knapweed near Grange, and as time allows we will be treating Scotch and musk thistle in the Butte area. The crew will work in cooperation with the WMA partners in the southeastern part of the WMA.

Equipment:

This will include a 100-gallon tank, 15 gallon auxiliary tank, emergency wash tank, personal safety gear and 2 backpacks. This will be considered part of the WMA in-kind contribution.

Mapping:

See attached map for current weed locations. All areas treated and surveyed will be displayed on a map that will be submitted to all WMA partners and CDFA at the completion of the project.

Reporting:

A project report will be submitted at the completion of the contract and will include the following information: net acres or number of plants treated if less than 100 plants, gross area surveyed, control tool utilized, % change (reduction) between visits, graphs showing differences in acres treated between years for each species addressed, and photographs.
