

Small Business Profile: IOWA

Entrepreneurs, innovators, and small businesses are key players in the economy of Iowa. They make up most of the employer firms in the state, and their contribution is indispensable. Their diverse composition and the spectrum of opportunities they offer are captured in this *Small Business Profile*, using the most current federal data available.

Number of Businesses. The state had an estimated total of 257,800 small businesses based on the most recent data.¹ Firms with employees numbered 70,566 in 2005, of which an estimated 97.6 percent or 68,872 were small firms (fewer than 500 employees). Self-employment (including incorporated) increased by 11.7 percent, from 185,887 in 2004 to 207,715 in 2005.² In 2004, non-employer firms increased by 3.4 percent and numbered 188,954. Women-Owned Firms. Firms owned by women increased 11 percent between 1997 and 2002, from 57,527 to 63,821; they represented 27.0 percent of the state's total businesses in 2002. These firms (with and without paid employees) generated \$7.4 billion in revenues in 2002. Of the total number of women-owned firms, 13.7 percent or 8,749 firms were employer firms. In 2005, self-employed women totaled 71,506, an increase of 7.0 percent from 2004, and they represented 34.4 percent of self-employed persons in the state. Minority-Owned Firms.³ In 2002, Asian-owned firms totaled 1,776 and generated \$453 million in receipts; Black-owned firms numbered 1,610 and generated \$258 million in receipts; and Hispanic-owned businesses totaled 1,536 and created \$289 million in receipts. American Indian- and Alaska Native-owned firms numbered 640, and they generated \$84 million in receipts; the number of Native Hawaiian- and other Pacific Islander-owned firms was 17, and they generated \$7 million in receipts in 2002. ¹ The Office of Advocacy's estimated total of state small businesses is based on the percent of small businesses (2003 Census firm size data) multiplied by the state's total number of employer businesses in 2005 (Dept. of Labor). The 2004 number of non-employer firms is added to this total (Census Bureau).

² The definition of self-employment has changed; as a result, statistics in the *Small Business Profiles* before 2004 are not comparable.

³ Minority owners may belong to more than one minority group, so adding the different groups will result in double counting.

Business Turnover. New employer businesses in 2005 were estimated at 6,004, which is 0.8 percent more than the previous year. Business bankruptcies increased by 26.4 percent, to 455 in 2005, while business terminations decreased by 8.0 percent, to 6,802 during the same period. Employment. There were 63,767 employer firms with fewer than 500 employees in 2003;⁴ they provided 649,927 jobs in the state. These firms represented 97.6 percent of the employer businesses in the state and employed 52.7 percent of the state's non-farm private sector workforce (Table 1). Between 2002 and 2003, total small business net new jobs amounted to 9,885 (Table 2). (Source: U.S. Dept. of Commerce, Census Bureau, Statistics of U.S. Businesses.)

Small Business Income. Non-farm proprietors' income, which is a partial measure of small business income, increased by 8.8 percent to \$6.4 billion in 2005. (Source: U.S. Dept. of Commerce.)

Finance.⁵ Two important sources of small business financing are commercial banks and savings and loan institutions, which owners rely on for their financial needs. The total number of operating bank and savings bank branches in the state increased in 2005 (Table 3).
