JOB DESCRIPTION: Serves as a Nurse Practitioner by providing primary health care for patients of the Colorado River Service Unit at the Sherman Indian High School in Riverside, CA. GS-11: Performs essentially the same duties as those described at the GS-12 level, but under closer supervision. **GS-12**: Incumbent makes assessments and provides comprehensive and therapeutic medical care to adult and adolescent patients. Makes diagnosis and decisions concerning medical and nursing care needs of patients, formulates and implements plan of care which may involve various treatment modalities, prescribing medications, consultation with other health care providers, and referrals. Performs therapeutic and emergency care procedures which include dispensing medications, giving injections, administering oxygen, providing wound care, applying cast and splints, performing minor surgical operations and carrying out resuscitative measures in life threatening situations. Performs minor surgical and invasive procedures; gives direct physical and psychological care in emergencies; prescribes medications as delineated in the approved clinical privileges and in accordance with current DEA licensure for a variety of symptoms and illnesses; documents data, patient assessment and care plans in acceptable form in medical records. Assesses plans and is involved in meeting the health needs of community and group health needs, and develops and conducts health education classes. Provides counseling and teaching to patients and their families on preventive, curative and rehabilitative measures involved in health care. Incumbent is expected to rotate to other Service Unit clinical sites during periods that the school is not opened. Performs other duties as assigned.

Qualified disabled applicants (Rehabilitation Act of 1973) and disabled veterans with 30% or more disability are encouraged to apply. Reasonable accommodations will be made for qualified applicants with disabilities, except when doing so would impose undue hardship on the Indian Health Service.

CONDITIONS OF EMPLOYMENT:

- 1. Selectee(s) are required to be immunized against Measles and Rubella and provide documentation prior to or at the time of their start date.
