- Fuel purchases for vehicles (rental, personal, or ORNL owned)
- Gifts, gift certificates, greeting cards, wrapping paper, art supplies
- Paper plates, napkins, utensils, cups
- Rental (formal wear, rooms, vehicles)
- Serving dishes
- Tablecloths and/or dressings

Office Decorations

Over the Counter Medicine & Medical Supplies (e.g. Aspirin, Band Aids, Antiseptic)
