## Public Meetings on Draft Supplement Analysis for the Final Environmental Impact Statement for the Nevada Test Site and Off-Site Locations in the State of Nevada

The National Nuclear Security Administration Nevada Site Office (NNSA/NSO) has prepared a Draft Supplement Analysis to the Nevada Test Site Environmental Impact Statement (NTS EIS). The supplement analysis process evaluates whether the NTS EIS continues to adequately address the environmental impacts of ongoing NTS activities as well as those contemplated over the next five years. NNSA/NSO will hold public meetings in an open house format as described below.

The Draft Supplement Analysis is available on the NNSA/NSO website (<a href="www.nv.doe.gov">www.nv.doe.gov</a>) or by writing to the address below or by sending electronic mail to <a href="nts-sa@nv.doe.gov">nts-sa@nv.doe.gov</a>. The document is also available at the NNSA/NSO public reading room located at 755 East Flamingo, Las Vegas, Nevada, and at the public libraries in the following communities: Carson City, Fallon, Tonopah, Beatty, Caliente, and Pahrump, Nevada and St. George, Utah.

The NNSA/NSO published the NTS EIS in October 1996 and issued a Record of Decision in December 1996. The NTS EIS addresses the potential impacts of work at the NTS in accordance with the National Environmental Policy Act (NEPA).

Agency NEPA implementing procedures require site-wide EIS's to be reviewed every five years to determine if they continue to adequately address the environmental impacts of activities at the relevant site or facility. The results of the evaluation are documented in a supplement analysis. The first Supplement Analysis to the NTS EIS was completed in 2002.

The current Draft Supplement Analysis to the NTS EIS documents the second five-year review of the NTS EIS. The document encompasses ongoing and reasonably expected work for the next five years for NNSA/NSO sites in Nevada since the 1996 Record of Decision.

The supplement analysis process serves as the basis for one of three determinations by NNSA: 1) the existing NTS EIS remains adequate, 2) the existing site-wide EIS should be supplemented, or 3) a new site-wide EIS should be prepared.

The public comment period for the Supplement Analysis is open until 4 p.m. (PDT) May 30, 2008. The public can comment in a number of ways. First, comments can be submitted in writing to:

Following the comment period, NNSA/NSO will revise the Supplement Analysis in response to comments received, as appropriate. The Final Supplement Analysis is expected to be completed by September 30, 2008, following which NNSA will make one of the three determinations as outlined above.
