^a Tungsten removed and vanadium reduced. Phosphorus precipitated at 10° to 20° C., washed with a 1-percent solution of KNO₃, and titrated with alkali standardized by the use of acid potassium phthalate and the ratio 23 NaOH:1 P.
^b Bismuthate (FeSO₄-KMnO₄) method after ZnO separation.
^c Tungsten removed after HCl-HNO₃ digestion followed by fuming with HClO₄. Phosphorus precipitated with molybdate in hot nitric acid solution and ultimately weighed as Mg₃P₂O₇. (Phosphorus not detected in tungstic acid residue.)
^d Double dehydration.
^e Finished by electrolysis.
^f Persulfate oxidation, potentiometric titration with ferrous ammonium sulfate solution standardized with recrystallized potassium dichromate.
^g α-Benzoinoxime method after removal of tungsten by acid digestion. Corrected for molybdenum occluded in tungsten, and the main molybdenum precipitate corrected for ammonia insoluble, and tungsten. See BS J. Research 9, 1 (1932) RP453.
^h Single precipitation by acid digestion and cinchonine. Tungsten corrected for silicon, iron, chromium, vanadium, and molybdenum.
ⁱ Chromium volatilized as CrO₂Cl₂.

^j Titrating solution standardized by use of a standard steel.
^k Perchloric acid dehydration.
^l Ammonia-copper-complex colorimetric method.
^m Glyoxime precipitate ignited and weighed as NiO.
ⁿ Precipitated with H₂S in tartaric or citric acid solution, purified, and weighed as MoO₃.
^o Tungsten separated by acid hydrolysis and cinchonine, purified by carbonate fusion, and finally precipitated with HgNO₃. Ignited oxide corrected for molybdenum and vanadium.
^p Chromium separated with ZnO. Finished by bismuthate-arsenite method.
^q Combustion.
^r Glyoxime precipitate titrated with KCN solution.
^s Chromium separated with ZnO.
^t Tungsten removed and phosphorus precipitated as the molybdate in hot, strong nitric acid solution.
^u Nitric-hydrochloric acid dehydration.
^v Ferrous sulfate-persulfate-KMnO₄ titration method.
^w Bismuthate-arsenite.
^x KI-Na₂S₂O₃ titration.

^y Solution in HCl, digestion with HNO₃ and precipitation with cinchonine. Precipitate dissolved in NH₄OH and tungsten precipitated by acid-hydrolysis and cinchonine. Ignited oxide corrected for silicon, iron, chromium, and molybdenum.
^z H₂S-α-benzoinoxime-CuO.
^{aa} Molybdenum precipitated as MoS₃ from tartaric acid solution, precipitated with α-benzoinoxime, ignited, and weighed as MoO₃.
^{ab} Major portion of tungsten precipitated from a 1-g sample by fuming with HClO₄ and HF. Molybdenum and remaining tungsten precipitated with α-benzoinoxime. Combined precipitates ignited to constant weight at 520° C and weighed. Oxides then heated at 750° to 800° C for 1 hour and weighed. The difference in weights represents the molybdenum volatilized. Residue analyzed for NaOH insoluble and molybdenum, and tungsten determined by difference.
^{ac} Permanganate oxidation.
^{ad} Hydroquinone colorimetric method. See Z. Anal. Chem. 114, 170 (1938).
^{ae} Copper precipitated as CuCNS. Finished by KI-Na₂S₂O₃ titration.
^{af} Chromium oxidized by phosphoric-perchloric acid mixture.
