SNJV supports the mission and objectives of the NNSA/NSO Environmental Management Program, and the Defense Threat Reduction Agency, and administers the Federal Facility Agreement and Consent Order. SNJV directly supports the National Nuclear Security Administration Nevada Site Office Environmental Restoration Project in its characterization and cleanup of approximately 2,000 sites on the Nevada Test Site and the Nevada Test and Training Range.
