The WSDA Organic Food Program certifies over 1,100 organic producers, processors and handlers. The open position would evaluate applications and inspection reports for compliance with National Organic Standards and international organic standards. Organic Certification Specialists communicate with organic producers over the phone and through email and letters. Organic Certification Specialists make recommendations on issuing organic certificates or taking enforcement actions when violations occur.
