If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: It is expected that the 3 above wetlands provide functional capacity for floodwater delay and storage, pollutant retention and removal (e.g., nitrogen, sediments) and primary production. Some differences would exist for Wetland MS West given its capacity to intercept auto-related pollutants in runoff from Marine Dr. and an adjacent parking. Further, these wetlands, which contain a diversity of community types, would be expected to provide wildlife habitat in varying degrees for invertebrates, amphibians and reptiles, water- and songbirds, and mammals. Wetland PFOC is located approximately 225 feet from the relevant reach tributary and approximately 170 feet from Wetland MS West but also is located on what is likely a related intermittent tributary. This close proximity between the various wetlands and two tributaries creates an ecologically linked set of aquatic and semi-aquatic habitats.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Other: (explain, if not covered above): **Wetland MS 5-6 , on the west side of Marine Dr., is a roadside ditch wetland that is remotely located (i.e., separated from other wetlands by uplands), without any surface connection to other wetlands on either side of the roadway. Its small size also reduces its capability to provide substantial functions.**

MS East, located on the east side of Marine Dr. , is divided by Sundial Road with a culvert beneath Sundial. It is a depressional wetland that has no surface connection to any tributary with a connection to a TNW. Light industrial development northeast and northwest of the wetland plus Marine Drive have eliminated any historical or present drainage to a tributary. Also, there is no culvert beneath Marine Dr. that would connect MS East and the wetlands that abut a seasonal creek (a.k.a. Fairview Lake Tributary) on the west side of Marine Dr. Marine Dr. further creates a significant impediment to any ecological connection with the wetlands and drainage on the west side of Marine Dr. MS East wetland, therefore, is not adjacent to a tributary.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Note: At Section 1D, site visit limited to project area wetlands adjacent to roadway, but did not include Fairfield Lake Tributary. In Section III.B. 1. ii. (b) for stream geometry, channel is at top of watershed with some early meandering (i.e., sinuosity about 1.2). Wetland MS West, in combination with the 2 other wetlands located within the relevant tributary reach, support the integrity of the TNW for the following reasons: First, these wetlands, combined with the Fairview Lake Tributary provide a mosaic of habitats that would be expected to support a diverse assemblage of small mammals and herp species, including turtles, snakes, frogs, and salamanders, all of which would be species common to the TNW. Secondly, although having varying opportunities for filtering pollutants, these wetlands sustain viable plant communities and microbiota that would function to perform such filtering. Finally, these wetlands are located at the headwaters of the subwatershed and would be expected to provide an important stormwater retention service, particularly since immediately downgradient are located hundreds of residences located on the shoreline of Fairview Lake.
