WEATHER SUMMARY

NOVEMBER: North Carolina experienced above average temperatures the first full week of November, average temperatures the second week, and below average temperatures late in the month. By the week ending November 30, cotton harvest and small grain plantings were nearing completion, and hay, sorghum and sweetpotoes were 100% harvested. Other activities in November included the harvesting of soybeans, the marketing of livestock, and general farm maintenance.






MONTHLY PRICE RECEIVED FOR CORN

(Dollars per Bushel)




MONTHLY PRICE RECEIVED FOR UPLAND

(Dollars per Bushel)




UPLAND COTTON YIELD (Pounds)


TURKEY HATCHERY - North and South Atlantic Region: Eggs in incubators on December 1, 2008 totaled 9,368,000. This total is down 8% from the 10,160,000 eggs reported on December 1, 2007. Poults hatched during November 2008 totaled 7,734,000, a 9% decrease from the 8,533,000 poults hatched in November 2007.

CHICKEN EGGS - South Atlantic Region: Broiler-Type eggs in incubators on November 1, 2008 totaled 217,591,000. The total was down 9% from the November 2007 total of 237,891,000 eggs. The total number of Egg-Type eggs in incubators on November 1, 2008 increased 3% from the previous year to 4,056,000 eggs.
