A few notes about your new license:

- **Customer Identification Number (CID)**
 - Replaces your backtag number
 - Permanent and will not change from year to year
 - Have this number ready when calling the PGC
 - Used instead of your backtag number on the unsold antlerless deer license application
 - Used in place of a senior lifetime and DV lifetime ID card to obtain yearly renewal licenses
- **Carcass Tags:** The tags that come with this license have two perforated holes in the center. These may be punched out to attach the tag to your carcass.
- **Signature:** Sign each license/permit on the appropriate line with a ballpoint pen. Parents must co-sign for juniors.

Availability: Only a few issuing agents are currently selling licenses through PALS. Add-on licenses (archery, muzzleloader, bear, etc.) or replacements must be purchased from one of these agents. PALS licenses are also available through The Outdoor Shop (www.pgc.state.pa.us). If you choose to purchase a bear license through PALS online, you cannot hunt for bear until the physical license is delivered to you with a harvest tag. During the pilot phase this year, most licenses are available for purchase through PALS except antlerless deer licenses. Resident Disabled Veteran and Resident Armed Forces antlerless licenses are currently available through PALS in three County Treasurer offices: Cumberland, Schuylkill and York. If you possess a DMAP coupon, you may redeem it at a PALS agent to purchase a DMAP Harvest Permit.

Harvest Reporting: Licenses issued through PALS do not include pre-printed harvest report cards. To report a deer or turkey harvest that was tagged using a 2008 general hunting license issued through PALS, please use the form on page 33 of the 2008 Hunting and Trapping Digest.

Antlerless: Licenses issued through PALS do not include a pre-printed antlerless deer license application. You will be limited to applying for unsold antlerless deer licenses this year using the unsold antlerless deer license application form in the 2008 Hunting and Trapping Digest, page 54. On the form itself, you will need to enter your CID in place of "Backtag No. & Letter."

Display: Hunting and Furtaker licenses issued through PALS can be folded to fit in a license holder. If you apply for a 2008 unsold antlerless deer license after you purchase a general hunting license through PALS, the antlerless deer license must be displayed on your back.
