GRAIN INSPECTION FEES AND CHARGES

EFFECTIVE DATE: August 1, 2008 "Federal Grain Inspection Service (FGIS) must approve all fees for official services and Official Agencies (OAs) will assess only those fees appearing on their current approved fee schedule."

REGULAR HOURS: 7:00 a.m. to 4:00 p.m. Monday through Friday except holidays. All other weekly hours, Saturday, Sunday, and holidays will be considered overtime.

Service requests not covered by listed fees will be assessed at \$ 15.00 per hour during regular working hours or the overtime rate stated herein as actual hours worked are in half-hour increments.

STANDBY HOURLY RATE: \$ 15.00 per hour assessed for all applicant caused delays. Charged actual time in half-hour increments.

OVERTIME HOURLY RATE: \$ 22:50 per hour individual assessed in half-hour increments in addition to unit fees.
Minimum call-out of 4 hours per man.

HOLIDAYS and SUNDAYS: \$ 30.00 per hour. New Year's Eve (At 11:00 AM) and Day, Presidents Day, Memorial Day, July 4th, Labor Day, Thanksgiving Day, Christmas Eve (At 11:00 AM) and Christmas Day. Holidays which fall on Saturday will be celebrated on the preceding Friday, those which fall on Sunday will be celebrated on the following Monday.
Minimum call-out of 4 hours per man.

MILEAGE/ TRAVEL TIME/ USER FEE RATES: The IRS standard mileage rate will be assessed all miles traveled outside Cairo city limits. (Prorated when possible) Any change to the mileage rate is effective when the IRS changes their standard mileage rate. Travel time will be assessed at the applicable rate. User fees will be assessed at the rate of 1.1 cents per metric ton as stated in Federal Register Notice Ref: Vol 70, No 165, 7CFR Part 800 Dated 8-28-05.

OFFICIAL SERVICE: Includes sampling and grading EXCEPT as indicated. *Fees include FGIS supervision fees*

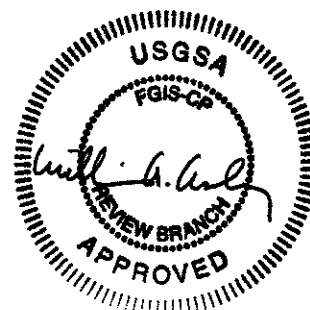
