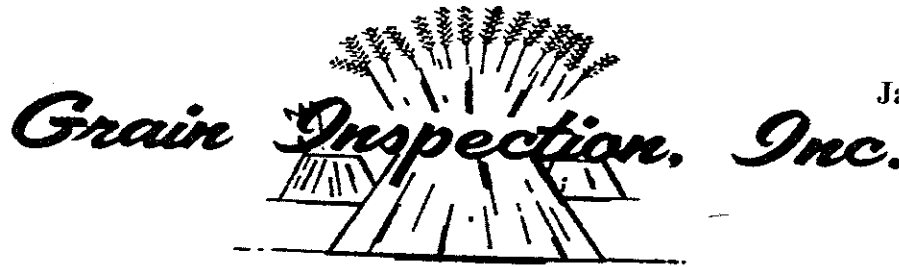

Effective Date: December 1, 2008 This fee schedule supersedes all other fee schedules issued by this office. Federal Grain Inspection Service (FGIS) must approve all fees for official services and Official Agencies will assess only those fees appearing on their currently approved fee schedule. FGIS user fees included.

REGULAR HOURS

Office Hours: 6:00 AM to 2:00 PM – Monday thru Friday

Inspection Hours: 5:00 AM to 2:00 PM – Monday thru Friday. If you would like same day inspection, please notify us by 9:00 AM. For weekend or holiday inspection service, please notify us by 12:00 PM of the previous business day.

Sampling Hours: 6:00 AM to 5:00 PM – Monday thru Friday. For same day sampling, please notify us by 11:00 AM. For weekend or holiday sampling service, please notify us by 1:00 PM of the previous business day.

Overtime Hours: 5.00 PM to 5:00 AM - Monday thru Friday and all day Saturday.

Double Time: Will be charged for Sundays and Holidays.

Holidays Include: New Years Day, Martin Luther King Day, Presidents Day, Good Friday, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day, New Years Eve Day after 2:00 PM, Christmas Eve Day after 2:00 PM.

HOURLY RATES:

Regular Hourly Rate: \$13.98 per man hour, sampler/technician
\$16.62 per man hour, inspector

Overtime Hourly Rate: Will be billed at one and half times the normal hourly rate and will be assessed in ¼ hour increments.

Stand-by Hourly Rate: Delays not caused by the agency will be billed at the applicable rate per man hour, and will be assessed in ¼ hour increments.

Travel Hourly Rate: Billed at the applicable rate per man hour, and assessed in ¼ hour increments. Prorated when possible. (Plus mileage.)



Minimum Call Out Time: Two hour minimum, per person, to be billed at applicable hourly rate and prorated when possible.

Mileage: Mileage will be assessed at a rate of less than or equal to the IRS standard mileage rate and will be prorated when possible.

Finance Charge: 1 ½% per month after 30 days from statement date.

Official Commercial Inspection Services are offered and will be negotiated on a case-by-case basis from our officially approved fee schedule.

Volume Discount: Elevators will receive a 5 percent discount for any month their billing equals or exceeds \$3,000.

Scale Facility and D/T Sampler Inspection: Scales intended for official weighing and Mechanical Samplers intended for official sampling must be reviewed and approved prior to use. We can help with this process and the applicant will be billed at the applicable hourly rate.

Guaranteed service contracts may be arranged and will be negotiated on a case-by-case basis.

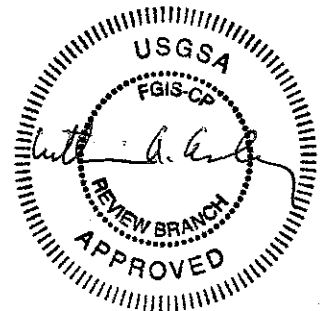
Service requests not covered by this fee schedule will be performed at the appropriate hourly rate, plus travel time and mileage.

Applicant selected sample delivery method cost to inspection laboratory, i.e. sampler travel time and mileage, actual cost of postage, freight, bus charges, express, etc...
