EFFECTIVE DATE: October 1, 2005. This revised fee schedule supersedes all other fee schedules issued by this agency. "Federal Grain Inspection Service (FGIS) must approve all fees for official services and OAs will assess only those fees appearing on their current fee schedule." All fees include FGIS user fees.

OFFICE HOURS: 8:00 A. M. to 4:00 P. M. Monday through Friday (excluding Holidays).

BILLING METHOD: Hourly rates are assessed in quarter hour increments per person. Overtime and Sunday/Holiday rates are assessed in addition to unit fees. Holidays include: New Years, Memorial Day, July 4th, Labor Day, Thanksgiving, Christmas Eve Day after 12 noon, Christmas Day.

Regular Hourly Rate: \$12.00 **Overtime Hourly Rate:** \$18.00

Sunday, Holiday Hourly Rate: \$24.00

Standby and Travel Time: Are assessed at the applicable rates shown above.

On-site Inspection: The applicable hourly rate per person, plus the unit fee.

MILEAGE RATE: The IRS standard rate for actual miles traveled, prorated where possible.

LODGING: Actual expenses are assessed per person when overnight stay is necessary.

OFFICIAL COMMERCIAL INSPECTION SERVICES: Is available, contact this office for information.

CONTRACTS: Contracts may be negotiated with any applicant to provide more cost effective service. Specific concessions may apply on a per contract basis.
