ORDER

LENGTH OF STAY RESTRICTIONS BLACK HILLS NATIONAL FOREST

Pursuant to Title 36 Code of Federal Regulations Section 261.50(a), the following are PROHIBITED:

- 1. CAMPING in any location or locations within the Black Hills National Forest, except designated recreational sites, or otherwise restricted by Special Order for a specific area, longer than a total of 14 days, (including any portions of days), in any 60 day period. {36 CFR 261.58(a)}
- 2. CAMPING for a period in excess of ten (10) consecutive days at the following designated recreation sites: Bearlodge, Bear Gulch, Beaver Creek, Bismarck Lake, Black Fox, Boxelder Forks, Castle Peak, Comanche Park, Cook Lake, Dalton, Ditch Creek, Dutchman, Hanna, Moon, Oreville, Pactola Lake, Red Bank Springs, Rifle Pit, Rod and Gun, Roubaix Lake, Reuter, Sheridan Lake North Cove, Sheridan Lake Southside, Timon, and Whitetail Campgrounds. {36 CFR 261.58(a)}
- 3. CAMPING for a period in excess of three (3) consecutive days at Horsethief Lake Campground and Custer Trails Campground. {36 CFR 58(a)}

The following are exempt from the prohibitions of this order:

- 1. Persons with a permit, (Special Use Authorization), specifically authorizing the otherwise prohibited act or omission.
- 2. Any Federal, State, or local officer in the performance of an official duty.
