TEMPORARY SPECIAL RESTRICTION

USE OF MOTORIZED VEHICLES ON PORTIONS OF FOREST SERVICE ROADS (FSR) FSR 284, CUSTER-LIMESTONE ROAD FSR 288, UPPER LIGHTNING CREEK ROAD

HELL CANYON RANGER DISTRICT BLACK HILLS NATIONAL FOREST

Pursuant to 36 CFR 261.50 (b), the following acts are prohibited on the National Forest System roads ("FSR") described in this Order within the Black Hills National Forest, Custer County, South Dakota until rescinded, or March 31, 2011 whichever event occurs first. The restricted roads are depicted on the attached map, hereby incorporated into this Order as Exhibit A. This prohibition does not apply from Memorial Day to Labor Day inclusive. This Order is necessary to protect public health and safety while logging operations are on going on in Unit #19 of the Round Mountain Timber Sale.

PROHIBITIONS:

Using any type of motorized vehicle on:

- That portion of FSR 284, Custer-Limestone Road, from Mile Post 5.7 to 7.5 and/or
 - That portion of FSR 288, Upper Lighting Creek Road, from Mile Post 4.8 to 5.6

36 CFR 261.54(a)

EXEMPTIONS:

Pursuant to 36 CFR 261.50(e), the following are EXEMPT from this order:

- 1. Persons with a Forest Service permit specifically authorizing the otherwise prohibited act.
- 2. Any Federal, State or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.

Violation of this prohibition is punishable as a Class b misdemeanor, by a fine of not more than \$5,000.00 for an individual, or \$10,000.00 for an organization or imprisonment for not more than six (6) months or both. Title 16 USC, Section 551, Title 18 USC, Section 3571.

JUSTIFICATION

This closure is necessary to provide for public safety while logging operations are on going on in Unit #19 of the Round Mountain Timber Sale. Due to the topography, trees will be felled and decked on the road surface. There may be on-going logging activity on any day of the week, including weekends.

This prohibition does not apply between Memorial Day and Labor Day inclusive since the timber purchaser is not allowed to operate in Unit #19 during that time period.

 - Persons with a permit specifically authorizing the otherwise prohibited act.
 - Persons working on the Round Mountain Timber Sale.
 - Any Federal, State or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.

- 6. HAS AN ENFORCEMENT PLAN AND A SIGN PLAN BEEN ESTABLISHED? Who will enforce the order? FPO's and LE&I staff Who will ensure proper signing? Hell Canyon Ranger District sale administration personnel. Signing is already in place.
- 7. WILL THIS ORDER BE REVIEWED ANNUALLY FOR NEED AND PROPER ENFORCEMENT? Yes
- 8. HAS PUBLIC BEEN NOTIFIED? Yes

DESCRIBE: Signs are in place and one news release was issued 8/28/2007 with another one to be issued 10/1/2007.
