Whereas, the citizens of the Township of (*Anytown*) and its surrounding areas are vitally important to the welfare of our community; and

Whereas, a large segment of these citizens ride in motor vehicles, operate motorcycles, use bicycles and walk on our city streets, use area highways and other thoroughfares; and

Whereas, (*X number*) of residents in (*Anystate*) were killed in motor vehicle crashes during 2001; and

Whereas, the Township of (*Anytown*) and its community commemorate these losses by participating in the activities associated with the World Health Organization's *World Health Day*; and

Whereas, obeying speed limits and restrictions on driving under the influence of alcohol or drugs, wearing motorcycle and bicycle helmets, using seat belts every time one rides in a car, and protecting children by placing them in age-appropriate safety seats and restraints in the back seat of a vehicle are strategies that have been proven to significantly reduce and prevent traffic-related injuries and deaths, thereby reducing the cost of providing health care services; and

Whereas, road traffic safety behaviors are supported by the laws of (Anystate);

NOW, THEREFORE I, (ANYNAME) MAYOR, of the Township of (Anytown, Anystate), do hereby proclaim April 7, 2004 as

World Health Day 2004
"Family Road Safety: Protect the Ones You Love"

and call for collaboration among offices of highway safety, departments of public health, and local organizations to coordinate activities that raise awareness about these tragic and preventable injuries. I also urge all citizens of (*Anytown*) and its surrounding community to recognize and appreciate the vital contributions that road traffic safety behaviors make to the well-being of our community and its citizens' health care by using seat belts, helmets and age-appropriate child passenger restraints, following speed limits, and not driving under the influence of alcohol or drugs this month and always.
