Active ingredient: Sodium Iodide, I-123

Form/Route: Capsule/Oral

Recommended studies: No in-vivo bioequivalence studies

Sodium Iodide I-123 capsule is a DESI¹-effective drug for which there are no known or suspected bioequivalence problems, and as such is rated “AA” in the FDA/CDER’s Approved Drug Products with Therapeutic Equivalence Evaluations (“Orange Book”).

Analytes to measure: Not Applicable

Bioequivalence based on (90% CI): Not Applicable

Waiver request of in-vivo testing: 100 µCi and 200 µCi capsules of the test product, based acceptable in vitro dissolution testing under 21 CFR § 320.22 (c).
