Assateague Island National Seashore Proposes Fee Changes in 2008

Assateague Island National Seashore (ASIS) Superintendent Scott Bentley announced today that the proposed 2008 fee schedule for the National Seashore is open for public comment until March 14, 2007. In accordance with the Federal Lands Recreation Enhancement Act of 2004 (REA) and National Park Service Policy, Assateague Island National Seashore (ASIS) is soliciting public participation to determine appropriate rates for recreation and use fees. National Park Service recreation and use fees are retained by the Agency. No less than 80% of fees collected at Assateague Island National Seashore are retained by the Seashore for specific services and projects such as repairing and maintaining visitor facilities, providing lifeguard services and administering permit programs.

Assateague Island National Seashore is scheduled for fee increases that are compatible with other similar national parks in 2008. As responsible stewards of the Seashore, staff routinely engages in market research to ensure fees are comparable with similar services and markets. Based on current market research, the following changes are proposed to take effect January 1, 2008.

Currently, 80% of the revenue generated from entrance fees remain at the Seashore. The most notable change in the proposed fee structure is a new Expanded Amenity Fee that would be charged by the Seashore on the Virginia end of the Island to off-set costs associated with National Park Service provided beach parking and lifeguard services. This new expanded amenity fee of up to \$3/day for each vehicle is in addition to Chincoteague National Wildlife Refuge's (Refuge) entrance fee, which is currently \$10/7-days. The Seashore expanded amenity fee is proposed to ensure sufficient funding is available to cover the costs of repairs associated with parking lot damage caused by annual storms and to provide summer lifeguard services. No Refuge entrance fee revenue is used to offset National Park Service costs associated with providing recreation on the southern end of Assateague Island. Currently, visitor use fee revenue generated from the Maryland end of the Seashore is used to off-set the cost of many projects on the Virginia end of the Island.
