Subject: Revision of Form TSP-U-16, Exception to Spousal Requirements

Date: August 1, 2002

The Federal Retirement Thrift Investment Board has revised <u>Form TSP-U-16</u>, <u>Exception to</u> <u>Spousal Requirements</u>, for use in the new record keeping system. The August 2002 revision of the form will be available from the **uniformed services section** of the Thrift Savings Plan (TSP) Web site at www.tsp.gov beginning August 23, 2002. An advance copy of the revised form is attached to this bulletin.

Purpose of Form TSP-U-16. Form TSP-U-16 is used by married participants who are requesting a waiver of the spousal requirements that must be met to obtain a TSP loan or withdrawal (in-service or post-employment). These requirements are delineated on the back of Form TSP-U-16 and are explained in the TSP loan and withdrawal booklets.

Service responsibilities. Participants may obtain Form TSP-U-16 from the TSP Web site or from the TSP Service Office. Services should also provide the form to participants upon request. Services may obtain the form by downloading it from the Web site, or they may have a representative of their central distribution point order a supply by completing the Thrift Savings Plan Publications Order Form (TSP-U-40).

By law, your spouse (including a separated spouse) has certain rights which must be taken into consideration when you withdraw or borrow from your uniformed services TSP account. The legal requirements are summarized in the chart below. It is your responsibility to obtain the signature of your spouse when it is required. The TSP will notify you of the decision regarding your request for an exception to the spouses' rights requirements. An exception may be granted only under limited conditions. Each statement must be signed and dated and must contain the following statement:

I understand that a false statement or willful misrepresentation in this form is a violation of law that is punishable by a fine of as much as \$10,000 or imprisonment for as long as 5 years or both (18 U.S.C. 1001).

13: Exceptional Circumstances. If you are requesting an exception to your spouse's waiver based on exceptional circumstances, you must attach either a court order or a governmental or uniformed services agency determination issued by the appropriate department or division head explaining the exceptional circumstances. For example, a court order could indicate that you and your spouse have been maintaining separate residences with no financial relationship for three or more years; or indicate that your spouse abandoned you but for religious or other compelling reasons, you chose not to divorce; or state that you may borrow money from or withdraw all or a portion of your TSP account notwithstanding the absence of your spouse's signature. A determination issued by a uniformed service could indicate that your spouse is a prisoner-of-war or is missing in action.
