Can the grant funds be used to provide the existing level of support services and case management to the expanded target population?	Grant funds may only be used to provide bump-up services for treatment group members only under the education/employment/training or the mentoring services component. Case management services are not an allowable cost under this grant.	
Can we use the award for the "bump-up" for both Education, employment and Training AND Mentoring or just one or the other?	It is preferred that the "bump-up" be a single, new, persistent service intervention but a service combination of training and mentoring would be allowable.	
If awarded the grant, are we expected to follow the cohort of youth throughout the 3 years?	Yes.	
Is the amount of the contract a yearly amount?	The amount of the grant award would be for three years.	
Can we serve only out-of-school youth? For the requested numbers in section 1 of the proposal do we need to separate in-school and out-of-school participants?	Yes, a grant can serve only out-of-school. Please separate in-school and out-of-school youth in your discussion of project participants.	
Can funding be used to pay for existing program structure if we are increasing the number of youth served?	No, grant funds can only pay for "bump-up' services.	
Does the age limit of 16 to 24 relate only to expectant mothers or to young parents as well?	The age limit of 16-24 is for all participants in the grant program.	
If this is an experiment are we required to have the project okayed by the board that okays Human experiences? I think it is the IRB or IRL board.	If the applicant requires Independent Review Board (IRB) approval to conduct human subject's experiments under this grant program then ETA will require the approval of this board before implementation of the grant.	

Can funding be used to pay for existing program structure if we are increasing the number of youth served?	No, grant funds can only pay for "bump-up" services.

Does the existing program only have to serve pregnant or parenting youth?	The Young Parents Demonstration program is to provide educational and occupational skills training leading to family economic self-sufficiency to both mothers and fathers, and expectant mothers ages 16 to 24.
In our grant application, do we have to designate the number of persons who would be served in the treatment ("bump-up") group vs. that of the control group?	Yes.

Please clarify: does the grant fund ONLY	The grant funds can only cover the individuals who receive the "bump-up."
the "bump-up" or does it also fund the existing services?	
Do all necessary components have to be provided by lead applicant or can it be a collaborative approach between partner organizations?	All of the necessary project components have to be provided by the lead applicant or a preexisting strategic partnership.
Regarding the 100 individuals to be served, must they all be teen/single parents or can they have another barrier?	The Young Parents Demonstration program is to provide educational and occupational skills training leading to family economic self-sufficiency to both mothers and fathers, and expectant mothers ages 16 to 24. Projects funded will be encouraged to serve young parents in high-risk categories, including those who are court-involved, in the child welfare or foster care system, homeless, or victims of child abuse.
Can funds be allocated for data collection activities and staff time?	Yes.
Regarding annual performance data: Are the number of youth who completed the program based on exits?	For performance measurement purposes, please see Part V. Section 1 of the SGA for further information on data collection.
For employment retention rates should we use YRR and YPRR or something else? Is the number of youth entering post-secondary education-while in the program or after exit?	
The total budget period should reflect a 3 year budget, in the aggregate should not exceed \$1,000,000, correct?	Yes. The Employment and Training Administration does reserve the right to award grants at a higher or lower amount, however.
I'm confused about the minimum numbers served. 100 minimum in our current program + those served in the 'bump-up'?	100 people total must be served by the program over the three year period – 50 receive the "bump-up" and 50 receive the regular program. Please note that this is a minimum and ETA encourages applicants to serve more individuals as feasible.
Can training (tuition) costs be built in for industry certifications in the "bump-up" component?	Yes.
Are Workforce Investment Boards (WIBs) eligible to be the applicant?	Yes.
Is a letter of commitment required if the WIB is the entity applying for the grant?	No.
What supportive services are allowed?	Supportive services are not an allowable

For an organization that does not currently have a Young Parents Program, will ETA accept an application that proposes to establish and conduct such a program, including provisions for a bump up and a control and experimental group? Do we need a local evaluator for the	If the program has each of the four necessary project components by themse or through an already existing strategic partnership serving this population or similar, then the applicant will qualify fo this grant. ETA will provide both a technical assistated and evaluation contractor to help grant
duration of the project and if so, can ETA funds be used for this?	recipients with the random assignment procedures and data collection.
Can all participants be recruited at the beginning of the project, or is a rolling admission expected with even recruitment across the 3 years?	Participants can be enrolled at the beginn of the project or on a rolling basis over the three years of the grant.
How may applicants best demonstrate the proposed cost per participant aligns with existing price structures for similar training in the local area?	The best way to demonstrate cost per participant is to research similar program the local area or the state that are providing similar services to similar populations.
May new partnerships be established to deliver a "bump-up"?	No. The bump-up should be delivered fradditional services through an existing strategic partnership.
Does the term "out-of-school" mean youth who have dropped out of high school, or can it be participants who have completed high school or earned their GED, but not enrolled in post-secondary education?	The term "out-of-school youth" means an eligible youth who is a school dropout; or eligible youth who has received a second school diploma or its equivalent but is baskills deficient, unemployed, or underemployed.
Are financial incentives or rewards allowed as part of the 'bump up" services?	Financial incentives and rewards are allowable under this grant as long as the are provided as part of the "bump-up" strategy. These incentives must be tied to milestones under the "bump-up" portion the grant only.
Within the "bump-up" component, can grant funds be used for staff salary - such as hiring mentors or college transition mentors/advisors?	Yes.
Can tables be single spaced?	Yes.
Could a bidder receive some bonus points for serving, say 50% in school and 50% out of school youth?	No. Bonus points will be awarded only i the applicant serves a majority of out of school youth.
Related to the Amendment, can the "bump- up" partner provider be a new partner?	No.

Do we have to submit our development and implementation of the random assignment method in the grant?	No. The random assignment method will be developed post-award.
Can grant funds be used to purchase computer hardware, software, and Internet connections?	Yes. On a limited basis and it must be approved by the ETA grants office prior to purchase.
Also, you stated grant funds could only be used for the 'bump-up' experiment with the exception of administrative costs, but the funds can also be used for indirect costs. Is that correct?	Yes.
Do both the control and treatment (bump- up) group get the standard service and the experimental group gets additional services?	Yes.
Can funds be utilized to ensure the "bump- up" services, i.e. specific case management, pre-training skill services for participants selected?	No, project funds cannot be used for case management only for the education/training or mentoring components.
Do both the control and treatment ("bump- up") groups get charged to the grant amount?	No. Grant funds can only be used for the treatment ("bump-up") group.
Since this will be an experimental design, will DOL need to approve the design, for example the methodology for random assignment?	Yes, but the project design process will be developed post grant award.
Once the awards are given, what is the time frame for start up of programs?	The implementation process for a project of this type is 3-6 months.
Can we pay for case management for the 'bump-up' group out of this grant?	No, case management services are not an allowable cost under this grant.
Can we provide a majority of bump-up services within the first 2 years to allow time for exit and follow-up?	Yes.
When partnering with a WIB, who would take the lead in receiving this grant? The WIB or the agency who administers the already existing program?	The agency who administers the existing program would take the lead in administering the grant.
If all necessary project components must be in place, how can you add a "bump-up"?	The "bump-up" should be a new, persistent intervention provided through an existing organization or strategic partnership as an additional service to the overall program.
