The reported transaction reflects the final determination by the issuer's Board of Directors to pay shares of common stock to the reporting person in connection with grants made under the issuer's performance share program for performance cycles covering 2003-2005 and 2004-2006. The issuer's Board initially determined to pay these shares in June 2007, subject to approval by OFHEO. On September 18, 2007, the Board determined to proceed with the payments after November 2, 2007, based on OFHEO's indication that it would not disapprove of the payments. These payments are discussed in Fannie Mae's Annual Report on Form 10-K for the year ended December 31, 2006, which was filed with the SEC on August 16, 2007.

End of period holdings include additional shares acquired from the reinvestment of dividends in issuer's ESOP through August 27, 2007.
