

J. TIMOTHY HOWARD'S ANSWER TO OFHEO'S NOTICE OF CHARGES

J. Timothy Howard hereby answers the Notice of Charges filed against him by the Office of Federal Housing Enterprise Oversight ("OFHEO") in the above-captioned matter. Pursuant to 12 C.F.R. § 1780.21(b), Mr. Howard responds below to each paragraph of the Notice of Charges. Any allegation of fact not expressly admitted is hereby denied. Moreover, to the extent Mr. Howard denies an allegation, he may do so not only because the allegation is false and untrue, but also because it suggests personal knowledge by Mr. Howard when in fact there was none.

PRELIMINARY STATEMENT

As set forth specifically below, Mr. Howard denies that, as the former Chief Financial Officer of Fannie Mae, he engaged in any misconduct or violated any statute, rule or order cited in the Notice of Charges. Far from constituting unsafe and unsound conduct, the decisions, practices, and policies challenged in the Notice of Charges were prudent, reasonable, and undertaken in good faith. They were reviewed and approved not only by the company's internal auditors and accountants, but also by the company's outside auditor, KPMG. They also were



reviewed and approved by OFHEO itself in the course of its annual examination process.

Indeed, year after year OFHEO reported to Congress that Fannie Mae was managed in a fashion that "exceeded" its expectations. The Notice of Charges, and the Special Examination that preceded it, are nothing more than an attempt by OFHEO to rewrite its own conclusions to meet political ends it now finds expedient.

AFFIRMATIVE DEFENSES

Without assuming any burden of proof that he would otherwise not bear, Mr. Howard also asserts the following defenses.

FIRST DEFENSE

The Notice of Charges fails to state a claim upon which the requested relief can be granted.

SECOND DEFENSE

The proper forum for this action is the United States District Court for the District of Columbia. In the alternative, this action should be arbitrated in accordance with Mr. Howard's employment agreement with Fannie Mae.

THIRD DEFENSE

The requested relief is not authorized by the Federal Housing Enterprises Financial Safety and Soundness Act of 1992, 12 U.S.C. § 4501 and/or is not authorized to be sought by the Director of OFHEO.

FOURTH DEFENSE

The Enterprise has not sustained any legally cognizable loss caused or likely to be caused by Mr. Howard.

FIFTH DEFENSE

Mr. Howard's conduct was at all relevant times in good faith.

SIXTH DEFENSE

Mr. Howard reasonably relied upon the work, conclusions, opinions, information, representations and advice provided by professional advisors, including but not limited to

accountants, auditors and attorneys, and OFHEO itself, whom Mr. Howard reasonably believed were experts in their field, and on whose advice he was entitled to rely.

SEVENTH DEFENSE

Mr. Howard reasonably relied upon the work, conclusions, opinions, information, representations and advice provided by government agency reports, including OFHEO, whom Howard reasonably believed were experts in their field, and on whose advice he was entitled to rely.

EIGHTH DEFENSE

OFHEO, by its acts, conduct, and omissions, is estopped, in whole or in part, from asserting the claims or obtaining the requested relief against Mr. Howard.

NINTH DEFENSE

OFHEO, by its acts, conduct, and omissions, have waived, in whole or in part, their claims and their right to obtain the requested relief against Mr. Howard.

TENTH DEFENSE

Civil penalties, as well as OFHEO's other claims, are barred by statutes of limitation and related statutory and/or jurisdictional bars, the doctrine of laches and/or unreasonable delay.

ELEVENTH DEFENSE

Any injury or loss sustained by the Enterprise was caused by independent, intervening, or superseding events caused by persons other than Mr. Howard.

TWELFTH DEFENSE

The penalties sought by OFHEO are excessive and exceed those permitted under the applicable law.

THIRTEENTH DEFENSE

The Notice of Charges violates the Due Process Clause of the Fifth Amendment insofar as it asserts violations of rules, regulations, orders, or laws of which Mr. Howard did not have fair notice and of rules, regulations, orders, or laws which are unconstitutionally vague, ambiguous, and/or overbroad.

FOURTEENTH DEFENSE

The Notice of Charges violates the Due Process Clause of the United States Constitution insofar as it asserts violations of purported rules, standards, and laws that took effect after Mr. Howard is alleged to have engaged in the misconduct alleged.

FIFTEENTH DEFENSE

OFHEO and its Director have predetermined the outcome of this proceeding in violation of the United States Constitution, the Administrative Procedure Act, the Safety and Soundness Act, and regulations thereunder and have forfeited their right to proceed.

SIXTEENTH DEFENSE

The Notice of Charges violates the Due Process Clause of the United States Constitution insofar as the charges were brought by a biased decision maker for an improper purpose.

SEVENTEENTH DEFENSE

The Notice of Charges violates federal law because OFHEO failed to seek the review and approval of the Secretary of Housing and Urban Development prior to filing.

EIGHTEENTH DEFENSE

The Notice of Charge's requested relief is excessive in violation of the Excessive Fines

Clause of the Eighth Amendment to the United States Constitution.

NINETEENTH DEFENSE

The Notice of Charges is barred by the business judgment rule.

TWENTIETH DEFENSE

The Notice of Charges is barred by the defense of entrapment by estoppel.

TWENTY-FIRST DEFENSE

The Notice of Charges is barred by the doctrine of acquiescence.

TWENTY-SECOND DEFENSE

The Notice of Charges is barred by the doctrine of contributory and/or comparative negligence.

TWENTY-THIRD DEFENSE

The Notice of Charges is barred because Mr. Howard discharged his duties as Chief Financial Officer of Fannie Mae in good faith and in full compliance with the duties of loyalty and due care required of an executive under applicable law.

TWENTY-FOURTH DEFENSE

The Notice of Charges is barred by the doctrine of *in pari delicto*.

TWENTY-FIFTH DEFENSE

The Notice of Charges is barred by the doctrine of unclean hands.

TWENTY-SIXTH DEFENSE

The Notice of Charges is barred due to OFHEO's failure to join indispensable parties.

TWENTY-SEVENTH DEFENSE

Any liability is subject to indemnification.

TWENTY-EIGHTH DEFENSE

OFHEO lacks jurisdiction or authority over Fannie Mae's financial statements and/or reports to the extent they fall within the oversight over the Securities and Exchange Commission or are governed by the Securities and Exchange Acts.

TWENTY-NINTH DEFENSE

OFHEO has forfeited the right to proceed by violating the law in connection with its purported special examination of Fannie Mae and Notice of Charges, including by revealing to the public certain reports.

THIRTIETH DEFENSE

Mr. Howard incorporates by reference any and all other defenses asserted by any other Respondent.

THIRTY-FIRST DEFENSE

Mr. Howard specifically reserves the right to incorporate any and all defenses raised by any other Respondent and any additional defenses that become apparent during the course of this case.
